ORDER REVOKING OPERATIVE AUTHORITY

By Decision No. 71213 dated August 30, 1966, in Application No. 48511, Wm. L. Corbett, doing business as Corbett Transit Lines, was granted a passenger stage operative right extending the operating rights previously granted him by this Commission in Ontario and adjoining communities. By the above Decision, Appendix A to Decision No. 68649 was amended to incorporate therein Route No. 2 Mountain Avenue - D Street.

By letter dated October 3, 1966 applicant advised the Commission that he did not wish to accept the operative right that had been sought in Application No. 48511 and granted in Decision No. 71213. Mr. Corbett stated in his letter that offers of financial assistance for the proposed service extension had been withdrawn and that he believed the operation of the proposed service extension without a subsidy would jeopardize the continuance of existing service.

Therefore, good cause appearing IT IS ORDERED that:

1. The operative authority granted Wm. L. Corbett by Decision No. 71213 dated August 30, 1966 in Application No. 48511 insofar as it pertains to Route No. 2, Mountain Avenue-D Street, is hereby revoked.

2. Appendix A of Decision No. 68649 is hereby amended by incorporating therein Second Revised Page 3, attached hereto, in revision of First Revised Page 3.

The effective date of this order shall be 20 days after the date hereof.

SECTION 2. Route Descriptions

Subject to the authority of this Commission to change or modify such at any time, William L. Corbett, doing business as Corbett Transit Lines, shall conduct said passenger stage operation over and along the following described route:

Route No. 1 - Ontario - Upland Line

Commencing at the intersection of Belmont Street and Sultana Avenue (Ontario), thence along Sultana Avenue, Francis Street, Euclid Avenue, Philadelphia Street, Fern Avenue, Phillips Street, Vine Avenue, Sunkist Street, Euclid Avenue, 5th Street, Campus Avenue, 7th Street, 2nd Avenue, Foothill Boulevard, Campus Avenue, 11th Avenue, San Bernardino Road, Arrow Highway, Campus Avenue, 9th Street, 2nd Avenue, 7th Street, Campus Avenue, 5th Street, Euclid Avenue, Sunkist Street, Sultana Street to Belmont Street.

\*Route No. 2 - Mountain Avenue - D Street

Applicant did not accept Dec. No. 71213 which authorized this route.
