## ORDER REVOKING OPERATIVE RIGHT

The certificate of public convenience and necessity granted to Roc Ross and Gil Gouveia, doing business as Re-Ly-On Van Service, has been suspended since May 10, 1966, for failure to maintain tariffs in conformity with a minimum rate order of 1 the Commission.

Roc Ross has informed the Commission by letter that the office furniture field has changed in the past ten years to the point where there is neither the necessity nor the demand for a scheduled carrier. He requests that the certificate of the partnership be revoked since it has reduced its equipment over the years and no longer provides this type of service.

In the circumstances, it appears, and the Commission finds, that revocation of the certificate of public convenience and necessity as requested would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the certificate should be revoked and the tariff applicable to services thereunder should be canceled.

The certificate authorizes service as a highway common carrier for the transportation of new and used, uncrated office furniture between San Francisco and East Bay points and between such points, on the one hand, and various northern California points, on the other hand.

IT IS ORDERED that:

 The certificate of public convenience and necessity to operate as a highway common carrier granted to Roc Ross and Gil Gouveia, doing business as Re-Ly-On Van Service, by Decision No. 50361, dated August 3, 1954, in Application No. 35420, is hereby revoked.

2. Roc Ross and Gil Gouveia, Doing Business As Re-Ly-On Van Service, Local Freight Tariff No. 1, Cal.P.U.C. No. 1, is hereby canceled.

The Secretary is directed to cause service of a certified copy of this order to be made upon Roc Ross and Gil Gouveia or to mail a certified copy thereof to them at their last known address as shown in the Commission's records.

The effective date of this order shall be the thirtieth day after such service upon Roc Ross and Gil Gouveia or after the above mailing to them unless before such effective date there shall have been filed with this Commission a written request for public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
