ORDER REVOKING OPERATIVE RIGHT

Harold C. Morton and Richard K. Jamison, doing business as Harbor Refining Company, possess a certificate of public convenience and necessity authorizing them to transport petroleum and petroleum products, in bulk, in tank trucks, between all points and places in the State of California. The partners have informed the Commission by letter that they are dissolving their partnership and accordingly request that the certificate be revoked.

In the circumstances, it appears, and the Commission finds, that revocation of the aforementioned certificate of public convenience and necessity will not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that said certificate should be revoked.

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a petroleum irregular route carrier granted to Harold C. Morton and Richard K. Jamison, doing business as Harbor Refining Company, by Decision No. 62903, dated December 5, 1961, in Application No. 43840, is hereby revoked.

2. Western Motor Tariff Bureau, Inc., Agent, is hereby authorized and directed to cancel the participation of Harold C. Morton and Richard K. Jamison, doing business as Harbor Refining Company, from the following tariffs:

Scope of Operations and Participating Carrier  
Tariff No. 4, Cal.P.U.C. No. 6;

Local Freight Tariff No. 16, Cal.P.U.C. No. 20;

Distance Table No. 5, Cal.P.U.C. No. 22; and

Local Freight and Express Tariff No. 18,  
Cal.P.U.C. No. 24,


on file with the Commission, such cancellations to be made within ninety days after the effective date of this order on not less than ten days' notice to the Commission and to the public.


