It is alleged that for the past several years applicant transported paper products for Paterson Pacific Parchment Co.; the transportation of these products requires special equipment and special handling in loading and unloading; said company now requests applicant to transport such products to points outside of his certificated area; on shipments destined to points within and without the scope of his certificated area applicant will not be able to provide his customer with the more favorable split delivery rates unless the authority herein requested is granted.

After consideration, the Commission finds that the requested authority would not be adverse to the public interest. A public hearing is not necessary. 2
