SUPPLEMENTAL OPINION AND ORDER

Decision No. 71521 dated November 9, 1966, in the above proceeding restricted the certificate of public convenience and necessity of McCloud River Trucking Company by specifying that not less than the applicable tariff rates shall be paid by such carrier to subhaulers engaged to carry property of its affiliated companies or corporations or property of the customers or suppliers of such companies or corporations.

McCutchen, Doyle, Brown, Trautman & Enerson, attorneys for McCloud River Railroad Company and McCloud River Trucking Company, informed the Commission by letter that a statement in the

above decision pertaining to ownership of Barbero Truck Lines and N.T.S. Inc. is not correct. The necessary correction will be made by the order herein.

IT IS ORDERED that:

1. Decision No. 71521 dated November 9, 1966, in Application No. 44706 is hereby amended by substituting the following sentence:

"Through purchase of stock, McCloud River Railroad Company owns Barbero Truck Lines, a corporation, and N.T.S. Inc., doing business as Norcal Transport Service."

in place and stead of the last sentence of page 1 of said Decision which reads:

"Through purchase of stock, McCloud River Trucking Company owns Barbero Truck Lines, a corporation, and N.T.S. Inc., doing business as Norcal Transport Service."

2. In all other respects, Decision No. 71521 shall remain in full force and effect.

The Secretary is directed to cause service of a certified copy of this order to be made upon McCloud River Trucking Company or to mail a certified copy thereof to it at its last known address as shown in the Commission's records and to mail a copy of this order to McCutchen, Doyle, Brown, Trautman & Enerson, 601 California Street, San Francisco, California, 94108.
