BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the matter of the Application of Carnelian Bay Water Company, a corporation, for an order authorizing an increase in rates for water service.

Application No. 48774 (Filed September 12, 1966)

#### OPINION

The applicant seeks authorization to combine its present summer and winter rates. It serves an area adjacent to Lake Tahoe in Placer County. A report signed by an engineer of the Commission's Utilities Division, Hydraulic Branch, and a Financial Examiner of its Finance and Accounts Division is received as Exhibit No. 1.

Applicant's service area contains 92 potential customers. Not all of these, however, subscribe for water service in any particular year. Notice of this application was duly given to customers in September 1966.

Applicant currently has on file a summer flat rate of \$30 and a winter flat rate of \$45. It seeks to combine these into an annual rate of \$75. The notices referred to above produced seventeen letters, most of which protested the elimination of seasonal rates. Many customers protested that they cannot reach their properties during the winter months because the county does not keep the roads open. They state that these are neither dedicated nor paved.

There have been no informal complaints against this utility since January 1, 1963. Apparently pressures have been adequate. Customers interviewed by the staff opposed annual rates but did not complain of service. The system has much pipe of substandard diameter and much that is not buried to an adequate depth.

A. 48774 AB The staff was of the opinion that, in spite of these deficiencies, service was reasonably adequate for this resort area. It would be unreasonable, however, to impose annual rates. Many customers cannot reach their properties in winter and if they could might find the utility unable to serve them because of frozen piping. The seasonal flat rates will be continued, but optional annual flat rates, together with annual and seasonal rates for metered service, will be established. The applicant has not kept its records in the manner prescribed by the uniform system of accounts. It will be ordered to do so. The staff estimated that, for the year 1967, applicant's present rates would yield 4 percent, unreasonably low, and the proposed rates 16.1 percent, unreasonably high. The staff developed rates calculated to yield 7 percent on its estimated rate base of \$18,420. These appear reasonable and will be adopted. The Commission finds that: The estimates of operating revenues, expenses, including taxes and depreciation, and the rate bases as submitted by the staff for the year 1967; reasonably represent the results of applicant's operations for the purposes of this proceeding. The increases in rates and charges authorized herein are justified, that the rates and charges authorized herein are reasonable, and that the present rates and charges, insofar as they differ from those herein prescribed, are for the future unjust and unreasonable. Applicant's records have not been kept in accordance with the Commission's uniform system of accounts. -2A. 48774 AB The Commission concludes that applicant should be authorized to increase its rates to the extent authorized by the following order. Applicant is placed on notice that it is expected to bury all new piping under at least thirty inches of cover wherever the nature of the terrain permits. It will further be expected to cover existing mains, wherever they are lowered, to allow the same cover and to design all of its installations to comply with General Order No. 103 of this Commission. ORDER IT IS ORDERED that: 1. After the effective date of this order, Carnelian Bay Water Company is authorized to file the revised rate schedules attached to this order as Appendix A. Such filing shall comply with General Order No. 96-A. The effective date of the revised schedules shall be March 16, 1967, or four days after the date of filing, whichever is later. The revised schedules shall apply only to service rendered on and after the effective date thereof. 2. Within ninety days after the effective date of this order, applicant shall file with the Commission two copies of a revised system map prepared as required by paragraph I.10.a. of General Order No. 103. 3. Within twenty days after the effective date of the filing of the rates authorized herein, applicant shall file an up-to-date tariff sheet Form No. 3, "Bill for Service". 4. Applicant shall maintain its books of account in accordance with the prescribed Uniform System of Accounts for Class D Water Utilities and by December 31, 1967 shall record therein the staff -3-

adjusted balances for utility plant accounts and depreciation reserve, at December 31, 1965, as set forth in the tabulation entitled "Utility Plant and Depreciation Reserve" contained in Exhibit 1 in this

5. Applicant shall compute and record in Ac. No. 503 and Ac. No. 250 its depreciation accrual for the year 1966 and subsequent years using the composite rate of 2.1 percent. It is further ordered that applicant shall continue to review its depreciation rates at not more than five-year intervals, as specified in Decision No. 59722, and that any rate or rates established in such a review and recognized by the Commission shall thereafter be used in recording future depreciation accruals and expenses.

The effective date of this order shall be twenty days after the date hereof.
