## SECOND AMENDMENT TO ORDER OF SUSPENSION AND INVESTIGATION

On January 18, 1966, the Commission issued an Order of Suspension and Investigation in Case No. 8335, suspending to and including May 29, 1966, the effective date of tariff sheets filed under The Pacific Telephone and Telegraph Company Advice Letter No. 9212; and on May 17, 1966, the Commission issued an Order Extending Period of Suspension to and including November 29, 1966; and on October 28, 1966, The Pacific Telephone and Telegraph Company filed a Supplement to Advice Letter No. 9212 requesting permanent suspension of said Advice Letter, and filed a substitute for it under Advice Letter No. 9407 to permit continuation of the investigation beyond the normal statutory limit. On November 22, 1966, the Commission issued a First Amendment to Order of Suspension and Investigation which permanently suspended the rates, classifications practices or rules filed under Advice Letter No. 9212, and suspended to March 27, 1967, the rules and special conditions in the tariff schedule filed under Advice Letter No. 9407.

It further appearing that a public hearing was held in this matter before Examiner Jarvis at San Francisco on May 2, 1966 and at Los Angeles on May 5, 1966. The matter was submitted subject to the

filing of late-filed exhibits and briefs on or before June 24, 1966. The late-filed exhibits have been received and briefs were filed by some of the parties. On December 30, 1966, the Commission directed that an Examiner's Proposed Report be filed, and on January 9, 1967 an Examiner's Proposed Report was filed; and it now further appears that a decision in this matter cannot be rendered by said date of March 27, 1967.

The Commission finds that the period of suspension should be extended; therefore,

IT IS ORDERED that the operations and effectiveness of the rules and special conditions in the tariff schedule filed by Advice Letter No. 9407 are hereby suspended to and including September 27, 1967, unless otherwise hereafter ordered.

The Secretary of the Commission is directed to cause a certified copy of this order to be served forthwith upon The Pacific Telephone and Telegraph Company.
