SUPPLEMENTAL OPINION AND ORDER

Decision No. 50853, dated December 14, 1954, in Case No. 5432 (Petition for Modification No. 49) exempted H. H. Fritz from observing the rates, rules and regulations contained in Minimum Rate Tariff No. 2 in connection with the transportation of shipments of wholesale drug supplies, each weighing 75 pounds or less, between Sacramento and various points along U. S. Highway 99-W from Corning to and including Redding.

Decision No. 66997, dated March 24, 1964, in the above proceeding, authorized the continuation of the above exemption in the name of Mildred H. Fritz, doing business as B-Line Express, in connection with the specialized transportation services formerly conducted by H. H. Fritz (deceased).

James R. Fritz has informed the Commission by letter that the highway contract carrier permit of Mildred H. Fritz, his mother, has been transferred to him. He requests that the current exemption be continued in his name inasmuch as he is continuing to conduct the specialized transportation services formerly performed by Mildred H. Fritz.

In the circumstances, it appears, and the Commission finds, that the continuation of the current exemption in the name of James R. Fritz by the substitution of his name in place of Mildred H. Fritz is justified. A public hearing is not necessary.


IT IS ORDERED that:

1. Decision No. 52199, in Case No. 5432, as amended, is further amended by substituting in the list of carriers in Appendix "C" thereof, the name of James R. Fritz, doing business as B-Line Express, in the place and stead of Mildred H. Fritz for the transportation of shipments of wholesale drug supplies, each weighing 75 pounds or less, between Sacramento and various points along U. S. Highway 99-W, from Corning to and including Redding.



This order shall become effective twenty days after the date hereof.




