SUPPLEMENTAL ORDER AND ORDER MODIFYING DECISION

Decision No. 72192, dated March 21, 1967 grants a certificate of public convenience and necessity to Toro Water Service, Inc. The effective date of that order is to be established by supplemental order after compliance with the requirements of ordering paragraph 8 of said decision.

A document filed with the Commission on April 11, 1967, indicates acceptable compliance with said ordering paragraph 8.

By letter dated April 13, 1967, the utility requests that page 1 of Appendix A of Decision No. 72192 be modified to reflect more equitable minimum charges for larger meters. The Commission finds this request to be reasonable; therefore,

IT IS ORDERED that:

Applicant is authorized to file the schedule of revised rates set forth in Appendix A of this order. The schedule of rates set forth on page 1 of Appendix A of Decision No. 72192 is revoked.

## APPENDIX A

## Schedule No. 1

GENERAL METERED SERVICEAPPLICABILITY

Applicable to all metered water service.

TERRITORY

The subdivision known as Corral de Tierra Oaks, and vicinity located on the south side of State Highway 68, approximately 8 miles west of Salinas, Monterey County.

RATES

First 1,000 cu.ft. or less .....	\$ 6.00
Next 1,000 cu.ft., per 100 cu.ft. ....	.40
Over 2,000 cu.ft., per 100 cu.ft. ....	.30
Minimum Charge:	
For 5/8 x 3/4-inch meter .....	\$ 6.00
For 3/4-inch meter .....	8.00
For 1-inch meter .....	10.00
For 1½-inch meter .....	20.00
For 2-inch meter .....	30.00
For 3-inch meter .....	52.00
For 4-inch meter .....	85.00

The Minimum Charge will entitle the customer to the quantity of water which that minimum charge will purchase at the Quantity Rates.
