SUPPLEMENTAL OPINION AND ORDER

Decision No. 72471 entered today in Case No.

5432 (Petition for Modification No. 405) et al., amended the rules of Minimum Rate Tariffs Nos. 2, 3-A, 6-A, 8, 10, 11-A, 12 and 14-A by providing that freight charges may be prorated, apportioned or divided between or among carriers.

The decision also provided that, in order to avoid duplication of tariff distribution, Minimum Rate Tariff No. 8 should be amended by a separate order in this proceeding.

IT IS ORDERED that:

1. Minimum Rate Tariff No. 8 (Appendix C to Decision No. 33977, as amended) is hereby further amended by incorporating therein, to become effective June 24, 1967, Second Revised Page 21-A attached hereto and by this reference made a part hereof.


2. Tariff publications required to be made by common carriers as a result of the order herein may be made effective not earlier than the tenth day after the effective date of this order on not less than ten days' notice to the Commission and to the public and shall be made effective not later than June 24, 1967.

3. Common carriers, in establishing and maintaining the rule authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the rule published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

4. In all other respects Decision No. 33977, as amended, shall remain in full force and effect.

The effective date of this order shall be twenty days after the date hereof.

A shipping document shall be issued by the carrier to the debtor for each shipment within 48 hours of the final delivery, computed from 12 o'clock midnight of the day of final delivery. §2. Freight Bill. A freight bill (either individual or manifest form) shall be issued by the carrier to the debtor for each shipment transported. \*Except with respect to intercarrier transactions and as hereinafter provided, only one freight bill shall be issued for each shipment transported and the carrier shall not apportion, prorate, or otherwise divide the freight charges between or among the consignor(s), consignee(s), or any other parties. For accessorial service not included in the rate for actual transportation, the carrier shall issue a freight bill to the consignor or consignee who requested or ordered such accessorial service. The freight bill shall show the following information: (See Note.)

(a) The information required of shipping documents as set forth in paragraph 1 of this item, or in lieu thereof specific reference may be made to the shipping document covering the shipment in question.

(b) Rate and charge assessed.

The form of shipping document in Item No. 800 will be suitable and proper.

A copy of each shipping document, freight bill, public weighmaster's certificate and other documents which support the rate and charge, shall be retained and preserved by the issuing carrier, subject to the Commission's inspection, for a period of not less than 3 years from the date of issue.

NOTE - A single combined shipping document and freight bill may be issued provided that all the information required of each is included on the single document.
