ORDER DISMISSING ORDER TO  
SHOW CAUSE IN RE CONTEMPT

By Decision No. 71353 issued October 4, 1966, this Commission ordered the defendant Greyhound Lines Inc., hereinafter sometimes called Greyhound, to cease and desist from utilizing unreasonable, inadequate and insufficient facilities for the receipt and discharge of passengers at Pollock Pines Junction and to furnish and maintain efficient, just and reasonable service, instrumentalities, equipment and facilities for the receipt and discharge of passengers at Pollock Pines Junction or at a location or locations in the immediate vicinity thereof. Greyhound was also ordered to file a full description of the location or locations, and the facilities thereon, to be used by it to receive and discharge passengers at Pollock Pines Junction.

Pursuant to said order Greyhound on December 5, 1966, filed a description of locations and facilities for receipt and discharge

of passengers at Pollock Pines Junction. On the same day the complainant herein, Pollock Pines Chamber of Commerce, hereinafter sometimes called Chamber of Commerce, filed an ex parte application for order to show cause in re contempt requesting that the Commission issue an order upon Greyhound to show cause why it should not be held in contempt for failure to comply with Decision No. 71353 and for costs.

Pursuant to the application of the Chamber of Commerce the Commission on December 13, 1966, issued its order requiring Greyhound to show cause why it should not be adjudged in contempt and punished according to law. Public hearings on the order to show cause were held at Pollock Pines before Examiner Cline on December 28 and 29, 1966. At the conclusion of the hearings, the matter was taken under submission subject to the filing of an opening brief by the Chamber of Commerce on or before March 15, 1967, and a closing brief by Greyhound on or before March 27, 1967. Such times were specified in order to give the parties an opportunity to negotiate with the Division of Highways for an improvement of the bus stops. It was provided that any time before March 27, 1967, the Chamber of Commerce could file a request for dismissal. Such time on the Commission's own motion is hereby extended to April 13, 1967, the date on which such a request was filed with the Commission by letter dated April 12, 1967 from the attorney for the Chamber of Commerce. Said letter is hereby made a part of the record in this proceeding by being designated Exhibit No. 47, and the matter is taken under submission as of April 13, 1967.

Exhibit No. 47 in part reads as follows:

"We have received a commitment from the Division of Highways that the bus stops will be built at the Sly Park Road interchange as soon as weather

permits. The complainant hereby moves to withdraw the application for contempt against Greyhound. . . .

"For the record, we note that the Division of Highways has not in writing agreed to allow any shelters or telephone installations to be built or installed at these bus stops. Without the shelters, the bus stops will remain inadequate. However, we are assuming that upon completion of the bus stops construction, that a permit will be granted by the Division of Highways whenever the applicant applies to install such shelter."

IT IS ORDERED that the order to show cause in re contempt issued by the Commission herein on December 13, 1966, is dismissed. The Secretary is hereby directed to mail a copy of this decision to the Department of Public Works as well as to the appearances of record.

The effective date of this order is twenty days after the date hereof.
