ORDER AMENDING DECISIONS

By Decision No. 72446 dated May 16, 1967, the Commission stayed the operative effect of Decisions Nos. 72371 and 72372 pursuant to Petition for Stay and Reconsideration filed by Northern California Grain Exchange.

By letter dated May 23, 1967, the above petitioner stated that it would have no further objections to Decisions Nos. 72371 and 72372 if the effective date of the tariff provisions involved were deferred from June 3, 1967, to August 1, 1967, and requested that such tariff provisions be so amended. California Farm Bureau Federation and California Trucking Association have informed the Commission by letter that they support petitioner's request. No objection to the granting of the request has been received.

The Commission, having considered the request of Northern California Grain Exchange, finds and concludes that Decisions Nos. 72371 and 72372 should be amended to provide that the tariff pages appended thereto should become effective August 1, 1967. Decision No. 72371 and Minimum Rate Tariff No. 2 will be amended accordingly by the order herein. In order to avoid duplication of tariff distribution, Decision No. 72372 and Minimum Rate Tariff No. 14-A will be amended by separate order.

IT IS ORDERED that:

1. Decision No. 72371 is hereby amended by substituting for Ordering Paragraphs 1 and 2 thereof the following:

"1. Minimum Rate Tariff No. 2 (Appendix D to Decision No. 31606, as amended) is further amended by incorporating therein, to become effective August 1, 1967, Eighth Revised Page 16-A, Fourteenth Revised Page 51 and Thirteenth Revised Page 51-A, attached hereto and by this reference made a part hereof.

"2. Tariff publications required to be made by common carriers as a result of the order herein may be made effective not earlier than the fifth day after the effective date of this order on not less than five days' notice to the Commission and to the public and shall be made effective not later than August 1, 1967." ✓

2. Minimum Rate Tariff No. 2 (Appendix D to Decision No. 31606, as amended) is further amended by incorporating therein, to become effective August 1, 1967, Supplement No. 71, attached hereto and by this reference made a part hereof.

3. In all other respects, Decisions Nos. 31606 and 72371, as amended, shall remain in full force and effect.

The effective date of this order shall be twenty-five days after the date hereof.
