SUPPLEMENTAL OPINION AND ORDER

By Decision No. 72675, entered today in Case No. 5432 (Petition for Modification No. 447) and Case No. 7857 (Petition for Modification No. 12), the Commission found that Decisions Nos. 72371 and 72372 in the above proceeding should be amended to provide that the tariff pages appended to said decisions should become effective August 1, 1967. The Commission also found that Decision No. 72372 and Minimum Rate Tariff No. 14-A should be amended by separate order to avoid duplication of tariff distribution.

IT IS ORDERED that:

1. Decision No. 72372 is hereby amended by substituting for Ordering Paragraphs 1 and 2 thereof the following:

"1. Minimum Rate Tariff No. 14-A (Appendix A to Decision No. 67397, as amended) is hereby further amended by incorporating therein, to become effective August 1, 1967, First Revised Page 12 and Third Revised Page 32, attached hereto and by this reference made a part hereof.




"2. Tariff publications required to be made by common carriers as a result of the order herein may be made effective not earlier than the fifth day after the effective date of this order on not less than five days' notice to the Commission and to the public and such tariff publications shall be made effective not later than August 1, 1967; and tariff publications which are authorized but not required to be made by common carriers as a result of the order herein may be made effective not earlier than the fifth day after the effective date of this order, and may be made effective on not less than five days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order."

2. Minimum Rate Tariff No. 14-A (Appendix A to Decision No. 67397, as amended) is further amended by incorporating therein, to become effective August 1, 1967, Supplement No. 2, attached hereto and by this reference made a part hereof.

3. In all other respects, Decisions Nos. 67397 and 72372, as amended, shall remain in full force and effect.

This order shall become effective twenty-five days after the date hereof.
