BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of PACIFIC MOTOR TRUCKING COMPANY for a certificate of public convenience and necessity authorizing operations as a highway common carrier of property, and of PACIFIC MOTOR TRANSPORT COMPANY for a certificate of public convenience and necessity authorizing operations as an express corporation, between Palmdale and Colton over California highways No. 138 and 395 to serve the lateral area between said highways and the Palmdale-Colton line of railroad.

Application No. 49297 (Filed April 18, 1967)

OPINION

Pacific Motor Trucking Company and Pacific Motor Transport Company request authority to extend their services as a highway common carrier and as an express corporation, respectively, for the transportation of property, except uncrated household goods and other related commodities for which the Commission has prescribed minimum rates in Minimum Rate Tariff No. 4-B, over existing Highway 138 from Palmdale to junction with California Highway No. 18 near the Los Angeles-San Bernardino County lines; thence continuing via Highway 138 to junction with U.S. Highway No. 395 near Cajon; thence via U.S. Highway No. 395 to intersection with Interstate Highway 10; thence west via Highway 10 to Colton with service authorized to, from or between points along the lines of railroad which are within the lateral territory bounded by the abovedescribed route, on the one hand, and the line of railroad known as the Palmdale-Colton Cutoff, on the other hand, as shown on Exhibit A attached to the application herein.

The application states that Southern Pacific Company has under construction a line of railroad known as the Palmdale-Colton Cutoff which diverges from the present San Joaquin Valley Line immediately south of Palmdale, California, crosses the Mojave Dessert generally north of California Highway No. 138 and connects with the present Sunset Route Line approximately one and one-half miles west of Colton, California, after descending through Cajon Pass. Anticipating establishment of rail stations along this line of railroad which is approximately 79 miles in length, Pacific Motor Trucking Company, the trucking subsidiary of Southern Pacific Company, has been asked by that company to secure intrastate operating authority permitting common carrier truck service between Palmdale and Colton with service authorized to and from points in the area to which rail service will become available between the new line of railroad and California Highway 138 Palmdale-Colton, thence U.S. Highway 395 Cajon-San Bernardino.

Decision No. 59977 of this Commission in Application
No. 41965 directs Pacific Motor Transport Company to join in applications of Pacific Motor Trucking Company in any future modifications of operating authority. Pacific Motor Transport Company desires that the services which it is authorized to offer remain co-extensive with those offered by Pacific Motor Trucking Company.

No protests to the granting of the application herein have been filed with the Commission.

After consideration, the Commission is of the opinion that public convenience and necessity require the granting of the authority sought. A public hearing is not necessary.

- (d) The tariff filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A.
- (e) Applicants shall maintain their accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of their operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

From junction U. S. Highway 66 and California Highway 30 near Upland, over California Highway 30 to Los Angeles-San Bernardino County Line.

From Los Angeles over U. S. Highway 99 to Los Angeles-San Bernardino County Line.

From Los Angeles over U. S. Highway 60 to Los Angeles-San Bernardino County Line.

Service is authorized at all intermediate points.

19.5 Between Los Angeles and Los Angeles-Orange County Line:

From Los Angeles over U. S. Highway 101-Alternate (Pacific Coast Highway) to Los Angeles-Orange County Line.

From Los Angeles over U. S. Highway 101 (Santa Ana Freeway) to Los Angeles-Orange County Line.

From Los Angeles over Whittier Boulevard, to Los Angeles-Orange County Line.

From Los Angeles over California Highway 11 (Harbor Freeway) to San Pedro.

From Lakewood over U. S. Highway 91 to Los Angeles-Orange County Line.

Service is authorized at all intermediate points subject to Special Condition 2.

19.6 Between Pomona and Los Angeles-Orange County Line:

From Pomona over unnumbered County Highway (Brea Canyon Road) to Los Angeles-Orange County Line.

Service is authorized at all intermediate points.

19.7 Between points in Los Angeles County:

Over any and all public streets, highways and thoroughfares west of a line projected between the northwesterly city limits of Sierra Madre and southeasterly city limits of Bakersfield, intersecting Los Angeles-Kern County boundary and south of a line projected from northwesterly city limits of Sierra Madre to junction U. S. Highway 66 and California Highway 30 near LaVerne, thence via California Highway 30 to Los Angeles-San Bernardino County boundary.

*Over any and all public streets, highways and thoroughfares east of Palmdale and west of Los Angeles-San Bernardino County boundary between California Highway 138 and Southern Pacific Company line of railroad known as the Palmdale-Colton Cutoff.
