IT IS ORDERED that the petition for rehearing of Decision No. 72418 and the Supplemental Statement seeking reopening of these proceedings be denied.

IT IS FURTHER ORDERED that:

1. Ordering Paragraphs 1, 3, 5 and 6 of Decision No. 72418 are hereby amended by substituting October 28, 1967, for July 1, 1967, now shown therein.

2. Minimum Rate Tariff 18 (Appendix B of Decision No. 72418, as amended) is hereby further amended by incorporating therein, to become effective October 28, 1967, First Revised Title Page and Supplement 2, attached hereto and by this reference made a part hereof.

3. City Carriers' Tariff No. 1-A and Minimum Rate Tariffs Nos. 1-B, 2, 3-A, 4-B, 5, 9-B and 11-A be amended by separate orders in the particular proceedings involved to avoid conflicts in the applications of the minimum rates in said tariffs with the minimum rates to be established herein.

4. In all other respects Decision No. 72418, as amended, shall remain in full force and effect.

The effective date of this order shall be the date hereof.
