SUPPLEMENTAL OPINION AND ORDER

Decision No. 73126, entered today in Case No. 5432

(Order Setting Hearing dated October 13, 1965) et al., denied the petition for rehearing of Decision No. 72418 and the Supplemental Statement to said petition seeking reopening of the involved proceedings filed by Trailer Coach Association and established an effective date of October 28, 1967, for Minimum Rate Tariff 18. The decision provided that Minimum Rate Tariff No. 5 be amended by separate order to avoid conflict in the application of the minimum rates in said tariff with the minimum rates in Minimum Rate Tariff 18.


IT IS ORDERED that:


1. Minimum Rate Tariff No. 5 (Appendix A of Decision No. 32504, as amended) is further amended by incorporating therein, to become effective October 28, 1967, Supplement No. 4, attached hereto and by this reference made a part hereof.


2. In all other respects Decision No. 32504, as amended, shall remain in full force and effect.
