ORDER REVOKING OPERATIVE RIGHT

By Decision No. 51630, dated July 5, 1955, in Application No. 36463, Bill Small, doing business as Bill T. Small Vacuum Truck Company (Small), was granted a certificate of public convenience and necessity to operate as a petroleum irregular route carrier for the transportation of petroleum and petroleum products in vacuum tank trucks and pump tank trucks between all points and places within the Counties of Los Angeles, Ventura and Orange.

The certificate of public convenience and necessity granted to Small was suspended on June 15, 1967, for failure to file an annual report pursuant to Resolution No. 15817, dated May 16, 1967. To date the required annual report has not been filed.

In the circumstances, it appears, and the Commission finds, that revocation of the certificate of public convenience and necessity would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the certificate should be revoked and that the tariff applicable to the service thereunder should be canceled.

IT IS ORDERED that:






1. The certificate of public convenience and necessity to operate as a petroleum irregular route carrier granted to Bill T. Small, by Decision No. 51630, dated July 5, 1955, in Application No. 36463 is hereby revoked.

2. Bill T. Small Vacuum Truck Company Local Freight Tariff No. 4, Cal.P.U.C. No. 4, is hereby canceled.

The Secretary is directed to cause service of a certified copy of this order to be made upon Bill T. Small or to mail a certified copy thereof to him at his last known address as shown in the Commission's records.

The effective date of this order shall be the thirtieth day after such service upon Bill T. Small or after the above mailing to him unless before such effective date there shall have been filed with this Commission a written request for public hearing, in which event the effective date of this order shall be stayed until further order of the Commission.
