SUPPLEMENTAL OPINION AND ORDER

By Decision No. 73433 issued today, the Commission found that revisions should be made in various minimum rate tariffs in connection with the transportation of houses. The decision also provided that, in order to avoid duplication of tariff distribution, Minimum Rate Tariff No. 9-B should be amended by separate order.

IT IS ORDERED that:

- 1. Minimum Rate Tariff No. 9-B (Appendix A of Decision No. 67766, as amended) is hereby further amended by incorporating therein, to become effective January 13, 1968, Fourth Revised Page 17, attached hereto and by this reference made a part hereof.
- 2. Tariff publications required to be made by common carriers as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than the tenth day after the effective date of this order on not less than ten days' notice to the Commission and to the public and such tariff publications shall be made effective not later than January 13, 1968; and tariff publications which are authorized but not required to be made by common carriers as a result of the order herein may be made effective not earlier than the tenth day after the

effective date of this order, and may be made effective on not less than ten days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff page incorporated in this order.

- 3. Common carriers, in establishing and maintaining the change authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the change published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.
- 4. In all other respects Decision No. 67766, as amended, shall remain in full force and effect.

This order shall become effective twenty-five days after the date hereof.

Liquids, compressed gases, commodities in semi-plastic form and commodities in suspension in liquids, in bulk in tank trucks, tank trailers, tank semi-trailers or a combination of such highway véhicles, Mushrooms, fresh (not cold pack nor frozen), Newspapers, newspaper supplements, sections or inserts Ø51 (not scrap nor waste). Nuts, in the shell, Nuts, field shelled (rough shelled, with or without removal of broken shells, dirt, residue, or foreign material, and not cleaned nor further processed), Poultry, live, Property shipped to or from producers of motion pictures or television shows when transported subject to the rates, rules and regulations provided by Decision No. 33226, in Cases Nos. +2+6 and ++3+, as amended, Property of the United States, or property transported under an agreement whereby the United States contracted for the carrier's services, Property transported to a United States Post Office for mailing, United States mail transported from a post office to the addressee thereof, and United States mail transported for the Post Office Department under contract, Telephone directories, Trailer coaches and campers set up, (including contents and furniture and other personal effects for use outside of trailer coaches) for which rates are provided in Minimum Rate Tariff 18, Used property, viz.: household goods, personal effects, furniture, musical instruments, radios, television sets and office and store fixtures and equipment as described in and for which rates are provided in Minimum Rate Tariff No. 4-B, and used property as described therein of state, county or municipal governments, or transported under an agreement whereby the governments contracted for the carrier's services,

Vehicles, fresh or green (not cold pack nor frozen),
Vehicles, disabled, when transported by towing,
Voting booths, ballot boxes, election tents, and election supplies when transported from or to polling places.
