Decision No. 73657

BEFORE THE PUBLIC UTILITIES COMMISSION OF THE STATE OF CALIFORNIA

In the Matter of the Application of DYKE WATER COMPANY, a corporation, for an order authorizing it to sell, transfer and convey a major portion of its water service system and utility plant in Orange County, California, to the CITY OF GARDEN GROVE WATER CORPORATION, a non-profit corporation under provisions of Section 351 of the Public Utilities Code, and for said City of Garden Grove Water Corporation to lease said water system to the City of Garden Grove.

In the Matter of the Application of DYKE WATER COMPANY, a corporation, for an order authorizing it to sell, transfer and convey its remaining water service system and utility plant in Orange County, California, to the CITY OF WESTMINSTER, a municipal corporation, under provisions of Section 851 of the Public Utilities Code, and for an order of the Commission relieving said Dyke Water Company of its utility obligation for public water service in said Orange County.

SUPPLEMENTAL ORDER

It appearing, from the Commission's records in the above entitled and numbered proceedings, that all obligations of Dyke Water Company, a dissolved corporation, for refund of advances in aid of construction in connection with various tracts and entities in portions of its former water system in Orange County, California, have been satisfied, and that the Commission has authorized certain trusts and agency agreements for payment of said refunds to be terminated,

Therefore, IT IS ORDERED that the Cities of Anaheim, Garden Grove, Westminster and Huntington Beach are, and each of said cities is, hereby relieved of any further obligation to maintain accounts or records respecting collection of revenues that would permit determination of construction advance refund obligations of Dyke Water Company in the portions of its former water system acquired by said cities.
