"Construction and maintenance expense shall be borne in accordance with an agreement entered into between the parties relative thereto, and a copy of said agreement, together with plans of said crossing approved by the Southern Pacific Company, shall be filed with the Commission prior to commencing construction. The costs of maintaining automatic crossing protection shall be divided the same as the costs of construction are divided by agreement between the parties."
