SUPPLEMENTAL OPINION AND ORDER

Andreas Truck and Warehouse Corporation (Andreas)

possesses a certificate of public convenience and necessity to

operate as a highway common carrier of general commodities, with

certain exceptions, between points within the Los Angeles Basin

Territory. It also possesses a prescriptive operative right as

a public utility warehouseman for the operation of storage or

warehouse floor space at Los Angeles.

On January 22, 1968, Eldon M. Johnson, attorney for Andreas, filed amended articles of incorporation of Andreas with this Commission changing the name to Star Truck and Warehouse Corporation. By letter dated February 21, 1968, Johnson requested that the fictitious names of Star Truck & Transfer Company and Pioneer Truck Company be added to the name of the entity.

Accordingly, the operative rights involved will be amended to show the new corporate and fictitious names and the public utility warehouse operative right will be restated in appendix form. The public utility will be ordered to amend its tariffs pursuant to the Commission's General Orders Nos. 61-A and 80-A. A public hearing is not necessary.

IT IS ORDERED that:

- 1. Decision No. 73494 dated December 19, 1967, in Application No. 49798, is hereby amended by substituting "Star Truck and Warehouse Corporation, doing business as Star Truck & Transfer Company and Pioneer Truck Company" in place and stead of "Andreas Truck and Warehouse Corporation".
- 2. The operative right as a public utility warehouseman acquired by Decision No. 73494, supra, is hereby revoked and, in place and stead thereof, a certificate of public convenience and necessity is granted to Star Truck and Warehouse Corporation as a public utility warehouseman, as defined in Section 239(b) of the Public Utilities Code, for the operation of storage or warehouse floor space as set forth in Appendix A attached hereto and made a part hereof.

3. Within one hundred twenty days after the effective date hereof, and on not less than ten days' notice to the Commission and the public, Star Truck and Warehouse Corporation shall amend its tariffs on file with this Commission as required by Rules Nos. 6.2 and 6.4 of General Orders Nos. 61-A and 80-A, respectively.

This order shall become effective twenty days after the date hereof.
