Application of GREYHOUND LINES, INC., for authority to reauthorize a portion of its presently authorized Del Mar Race Track special-service Route No. 13.07 as an alternate Route No. 18.04 and to extend such alternate route between Pasadena and Valley Boulevard Junction, Los Angeles County; and for incidental relief.

## <u>O P I N I O N</u>

Greyhound Lines, Inc., requests reauthorization of a portion of its Del Mar Race Track special-service Route No. 18.07 as an alternate Route No. 18.04 and to extend such alternate route between Pasadena and Valley Boulevard Junction, Los Angeles County.

It is alleged that the proposed alternate route will provide a more expeditious route for applicant through Pasadena-San Bernardino express schedules over the freeway.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

## <u>ORDER</u>

IT IS ORDERED that:

1. A certificate of public convenience and necessity is hereby granted to Greyhound Lines, Inc., authorizing the establishment and operation of service as a passenger stage corporation, as that term is defined in Section 226 of the Public Utilities Code, for the transportation of passengers, baggage and express between the points and over the routes set forth in Fifth Revised Page 61, attached

hereto and made a part hereof, as an extension and enlargement of and consolidation with, and subject to all the limitations and restrictions set forth in, the certificate granted by Decision No. 55893 and in particular subject to the provisions set forth in Section 3 of Appendix A thereof.

2. Appendix A of Decision No. 55893 as heretofore amended is hereby further amended by incorporating the revisions set forth on the revised page referred to in ordering paragraph 1 hereof.

3. In providing service pursuant to the certificate herein granted, applicant shall comply with and observe the following service regulations:

- a. Within thirty days after the effective date hereof, applicant shall file a written acceptance of the certificate herein granted.
- b. Within one hundred twenty days after the effective date hereof, applicant shall establish the service herein authorized and file tariffs and timetables, in triplicate, in the Commission's office.
- c. The tariff and timetable filings shall be made effective not earlier than ten days after the effective date of this order on not less than ten days' notice to the Commission and the public, and the effective date of the tariff and timetable filings shall be concurrent with the establishment of the service herein authorized.

d. The tariff and timetable filings made pursuant to this order shall comply with the regulations governing the construction and filing of tariffs and timetables set forth in the Commission's General Orders Nos. 79 and 98-A.

The effective date of this order shall be twenty days after the date hereof.

\*18.04 BETWEEN Pasadena and Valley Boulevard Junction:

From Pasadena, over Los Robles Avenue to junction Atlantic Boulevard (Atlantic Boulevard Junction), thence over Atlantic Boulevard to junction California Highway 212 (Valley Boulevard Junction), to be operated as an alternate route, except for purposes of joinder with Route No. 18.07.

18.05 BETWEEN South Alhambra Junction and El Monte Junction:

From junction U. S. Highway 60 and Atlantic Boulevard (South Alhambra Junction), over Atlantic Boulevard to California Highway 212, thence over California Highway 212 to junction U. S. Highway 60 (El Monte Junction).

18.06 BETWEEN junction Garfield Avenue and U. S. Highway 60 and junction Garfield Avenue and Valley Boulevard:

> From junction Garfield Avenue and U. S. Highway 60, over Garfield Avenue to junction California Highway 212.

\*\*18.07 BETWEEN Atlantic Boulevard Junction and South Alhambra:

From junction Atlantic Boulevard and Garfield Avenue (Atlantic Boulevard Junction), over Garfield Avenue to junction California Highway 212 (South Alhambra).

No passengers shall be transported over this route except those having either point of origin or destination at Del Mar Race Track and then only on days when racing is conducted at Del Mar Race Track.

Transportation of express over this route is not authorized.
