SUPPLEMENTAL OPINION AND ORDER

By Decision No. 72418, as amended by Decision No. 73126,
dated May 16 and September 26, 1967, respectively, in Case No. 5432
(Order Setting Hearing dated October 13, 1965) et al., the Commission
established effective October 28, 1967, minimum rates in Minimum
Rate Tariff 18 for the transportation of trailer coaches and campers,
including integral parts and contents when the contents are within
the trailer coach or camper (trailer coaches and campers).

The Commission notified all common carriers of general
commodities, including those named in Appendix A hereof, of the
foregoing fact stating that the required tariff filings should be
made by November 30, 1967, in the event that they hold themselves
out to perform the above transportation. The Commission also in-
formed these carriers that failure to make the required tariff

filings would be considered as evidence that they do not hold themselves out to perform this service and that consideration would be given to amending their certificates to exclude the transportation of trailer coaches and campers. The carriers named in Appendix A have not made the required tariff filings to date.

The required tariffs not being on file, the Commission finds that the aforementioned carriers have indicated by such inaction that they do not hold themselves out to perform the service in question and that amendment of their certificates to exclude the transportation of trailer coaches and campers would not be adverse to the public interest. The Commission concludes that the carriers' certificates should be amended accordingly. A public hearing is not necessary.

IT IS ORDERED that:

1. The certificates of public convenience and necessity granted to or acquired by the carriers named in Appendix A attached hereto authorizing them to operate as highway common carriers, as defined in Section 213 of the Public Utilities Code, are hereby amended by excluding therefrom the transportation of trailer coaches and campers, including integral parts and contents when the contents are within the trailer coach or camper.

2. Within one hundred twenty days after the effective date hereof, and on not less than ten days' notice to the Commission and to the public, each carrier named in Appendix A hereof shall amend its tariffs on file with the Commission covering

its common carrier operations described in said Appendix A to indicate that the rates in such tariffs do not apply to the transportation of trailer coaches and campers, including integral parts and contents when the contents are within the trailer coach or camper.

The effective date of this order shall be twenty days after the date hereof.
