OPINION AND ORDER

Minimum Rate Tariff No. 2 names minimum rates and rules for the statewide transportation of general commodities by highway carriers. By this petition California Trucking Association seeks to extend the expiration date governing certain provisions in the above tariff from June 30, 1968, to December 31, 1969.<sup>1</sup> By the above application, Pacific Southcoast Freight Bureau, on behalf of 10 common carriers listed therein, seeks to amend one of its tariffs by similarly extending the expiration date governing the volume incentive service provisions named therein.<sup>2</sup>

<sup>1</sup>These provisions pertain to the return transportation of empty pallets and small shipment and volume incentive services and such provisions are set forth in Items Nos. 45, 149, 292, 316, 320, 320-1, 338, 345, 350, 360 and 390 of the tariff.

<sup>2</sup>Applicant's proposal involves amendment of Item 740 of Pacific Southcoast Freight Bureau Tariff 294-E. (Tariff 294-E.)

Petitioner states that the above-mentioned provisions, which have been established on an experimental basis, have evolved from joint considerations of shippers and carriers and reflect the rate-making judgments of such parties. Petitioner avers that the expiration date was provided to insure that any detrimental effects upon either carriers or shippers would not be continued indefinitely.

According to petitioner, subsequent experience with these provisions has indicated a need for revisions which are responsive to the requirements of shippers and carriers but that involvement in other rate-making matters has prevented cooperative efforts in this direction.

Petitioner declares that the proposed expiration date will allow parties sufficient time to review their experiences and to present to the Commission for its consideration permanent rules and regulations regarding the involved tariff provisions. Petitioner alleges that the continuation of such tariff provisions until December 31, 1969, is desired by both shippers and carriers.

Applicant states that the proposed extension of the expiration date governing the volume incentive provisions in its Tariff 294-E is required in order that the current competitive situation between rail and motor carriers may continue to exist.

Copies of the petition were served upon various chambers of commerce, shipper organizations and carrier representatives on or about March 15, 1968. Copies of the application were mailed to California Manufacturers Association and California Trucking Association on or about April 9, 1968. The petition and application were listed on the Commission's Daily Calendar of March 18 and April 10, 1968, respectively. The Commission has received letters from interested parties stating that they support petitioner's proposal. <sup>3</sup>

<sup>3</sup> Letters in support of the petition were received from California Portland Cement Company, Capitol Records Distributing Corp., Challenge-Cook Bros., Inc., Economics Laboratory, Inc., Firestone Tire & Rubber Company of California, Phillips Petroleum Company, The Firestone Tire & Rubber Company, The Flintkote Company and Van Waters & Rogers.

No objection to the granting of the petition and application has been received.

In the circumstances, it appears, and the Commission finds, that petitioner's proposal is reasonable and the resulting minimum rates and charges will be just, reasonable and nondiscriminatory minimum rates and charges for the transportation involved. The Commission further finds that applicant's proposal is justified. A public hearing is not necessary. The Commission concludes that the petition and application should be granted. Other minor changes not related to the subject matter of the petition will be made in one of the tariff pages herein being revised.<sup>4</sup>

IT IS ORDERED that:

1. Minimum Rate Tariff No. 2 (Appendix "D" to Decision No. 31606, as amended) is hereby further amended by incorporating therein to become effective June 30, 1968, the revised pages attached hereto and listed in Appendix A, also attached hereto, which pages and appendix are made a part hereof.

2. Pacific Southcoast Freight Bureau is authorized to publish and file an expiration date of December 31, 1969, to govern the provisions of Item 740 of Pacific Southcoast Freight Bureau Tariff 294-E, as specifically proposed in Application No. 50154.

3. Tariff publications authorized to be made by common carriers as a result of the order herein may be made effective not earlier than the fifth day after the effective date of this order, and may be made effective on not less than five days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff pages incorporated in this order. Tariff publications authorized herein shall be filed not earlier than the effective date of this order.

## APPLICATION OF RATES

(Applies only when reference is made hereto)

(a) Rates in this item shall apply only on prepaid shipments when the shipping document is annotated by shipper certifying that the shipment meets the requirements of this item and requesting volume incentive service. Rates in this item do not apply to:

1. Shipments which require temperature control service, split pickup or delivery service, collect on delivery (C.O.D.) or order notify service, or which have origin or destination on steamship docks or oilwell sites; nor
2. Shipments moving on government bill of lading; nor
3. Shipments which are not loaded in their entirety during one calendar day; nor
4. Shipments subject to Items Nos. 85, 90 or 365.

(b) The charge for service under the provisions of this item shall be determined and applied as follows:

1. Determine the applicable classification truckload rating as provided in the Governing Classification for the shipment; and
2. Multiply the actual weight of the shipment (but not less than 45,000 pounds per unit of carrier's equipment used) by the applicable rate provided for the next lower rating (See Exception).

EXCEPTION:-Rate shall also apply to a shipment weighing less than 45,000 pounds provided the charges are computed on a weight of not less than 45,000 pounds per unit of carrier's equipment.

3. In no event shall the charge so determined be less than the charge for 50,000 pounds at the Class E rate.
