FIRST SUPPLEMENTAL OPINION

By Decision No. 74205, dated June 5, 1968, in the above-entitled matter, the Commission, among other things, authorized the merger of Rialto Publishing Company, Inc. and Matich Transportation Company. Said decision contemplated that the name of the surviving corporation would become Inland Associates, Inc. in accordance with a proposed Agreement of Merger, a copy of which is attached to Application No. 50208 as Exhibit C. Petitioner requests the Commission to make appropriate changes in the order in said Decision No. 74205 so as to eliminate the proposed name of Inland Associates, Inc.

The Petition for Modification filed in this proceeding indicates that the merger was consummated on or about June 14, 1968, and that the name of the surviving corporation will remain as Matich Transportation Company. Exhibit A, attached

to the petition, contains a copy of the Agreement of Merger as certified by the California Secretary of State. Petitioner has determined that the proposed change of name would not be practicably possible, nor in its best interests.

After consideration, the Commission finds that it will not be adverse to the public interest for petitioner to retain the name of Matich Transportation Company. On the basis of this finding we conclude that the petition should be granted. A public hearing is not necessary.

FIRST SUPPLEMENTAL ORDER

IT IS ORDERED that:

1. Ordering Paragraph No. 1 of Decision No. 74205 is hereby amended by eliminating therefrom "will, among other things, change its name to Inland Associates, Inc., and".
2. Decision No. 64628, dated December 11, 1962, in Application No. 44892, and Resolution No. 13823, Sub. No. 6, dated June 23, 1964, in Application No. 46362, are hereby further amended by substituting "Matich Transportation Company" in place and stead of "Inland Associates, Inc."
3. Ordering Paragraphs Nos. 3 and 4 are hereby deleted from Decision No. 74205.
4. Ordering Paragraph No. 5 of Decision No. 74205 is hereby amended by eliminating therefrom ", under its new name of Inland Associates, Inc.,".
5. The order in Decision No. 74205 shall remain in full force and effect except as modified by this order.

6. The effective date of this order is the date hereof.
