## ORDER REVOKING OPERATIVE RIGHT

The certificate of public convenience and necessity granted to Earl J. Hall and Erwin J. Hall, doing business as E. J. Hall & Son Transportation, was suspended on October 21, 1964, for failure to have on file requisite evidence of liability insurance. The certificate was continued in suspension until July 1, 1966, at the carrier's request, and again further suspended until November 20, 1967, to provide the necessary time to enable Earl J. Hall to recover from a hip fusion operation. To date the carrier has not filed the required tariffs, evidence of liability insurance or annual reports. Report forms sent to the carrier have been returned by the post office indicating no forwarding address.

The required tariffs, evidence of liability insurance and annual reports not being on file, resumption of common carrier operations not having commenced and a reasonable time having elapsed, the Commission finds that revocation of the

certificate would not be adverse to the public interest and concludes that the certificate should be revoked.

IT IS ORDERED that the certificate of public convenience and necessity to operate as a cement carrier granted to Earl J. Hall and Erwin J. Hall, doing business as E. J. Hall & Son Transportation, by Resolution No. 13821, Sub. No. 33, dated June 23, 1964, in Application No. 46550, is hereby revoked.

The Secretary is directed to cause service of a certified copy of this order to be made upon Earl J. Hall and Erwin J. Hall or to mail a certified copy thereof to them at their last known addresses as shown in the Commission's records.

The effective date of this order shall be the thirtieth day after such service or after the above-mentioned mailing unless before such effective date Earl J. Hall or Erwin J. Hall shall have filed with this Commission the required tariffs, evidence of liability insurance and annual reports, in which event the effective date of this order shall be stayed until further order of the Commission.
