## SUPPLEMENTAL OPINION AND ORDER

The minimum rates for parcel delivery service set forth in Item No. 425 of City Carriers' Tariff No. 1-A were established to meet the rates published and maintained by United Parcel Service, Inc. By Decision No. 74488, entered today, United Parcel Service, Inc., was authorized to increase its basic per-package rate from 24 cents to 29 cents, and the Commission concluded therein that in order to avoid duplication of tariff distribution City Carriers' Tariff No. 1-A should be amended by separate order to reflect the increases in the parcel delivery rates; therefore,

## IT IS ORDERED that:

1. City Carriers' Tariff No. 1-A (Appendix "A" of Decision No. 41363, as amended) is hereby further amended by incorporating therein to become effective September 14, 1968, Twenty-first Revised Page 40, attached hereto and by this reference made a part hereof.
