O P I N I O N

Airport Coach Service, presently rendering a passenger stage service between the Los Angeles International Airport, the Ontario International Airport and the Orange County Airport, on the one hand, and various points in Southern California, including Disneyland and Anaheim, on the other hand, requests that its certificated authority be extended to the Anaheim Territory, an area covering portions of the City of Anaheim, the City of Garden Grove, the City of Orange and the County of Orange bounded on the north by Lincoln Avenue, on the west by Brookhurst Street, on the south by Chapman Avenue and on the east by the Santa Ana River.

The proposed extension would result in no change in fares or schedules.

It is alleged that because of the rapid growth in the Anaheim area and particularly the area surrounding Disneyland, service can best be provided by territorial authority which would allow for greater flexibility in operations. Applicant also cites as a reason for filing the instant application a change in terminal facilities from the Disneyland Hotel to the Grand Hotel in Anaheim.

After consideration the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary.

ORDER

IT IS ORDERED that Appendix A of Decision No. 65057 in Application No. 44905 is hereby amended by incorporating therein Fourth Revised Page 2, Third Revised Page 3, Third Revised Page 4, Third Revised Page 5 and Original Page 6 attached hereto and by reference made a part hereof in place of Third Revised Page 2, Second Revised Page 3, Second Revised Page 4 and Second Revised Page 5.

After the effective date hereof and on not less than ten days' notice to the Commission and to the public applicant shall amend its tariffs and timetables presently on file with the Commission to reflect the authority herein granted.

The effective date of this order shall be twenty days after the date hereof.

SECTION 1. GENERAL AUTHORIZATIONS, RESTRICTIONS,  
LIMITATIONS, AND SPECIFICATIONS.

The certificate hereinafter noted supersedes all operating authority heretofore granted to Airport Coach Service, a corporation, or its predecessors.

Airport Coach Service is authorized to transport passengers, their baggage and express, between Newport Beach, Santa Ana, Orange, the Anaheim Territory\*, Fullerton and Buena Park, on the one hand, and the Los Angeles International Airport, on the other hand, and between Newport Beach, Santa Ana, Orange, Anaheim Territory\*, on the one hand, and the Orange County Airport, on the other hand, and between Anaheim Territory\*, on the one hand, and Ontario International Airport, on the other hand, and between the El Toro Marine Air Station, on the one hand, and Los Angeles International Airport, on the other hand, over and along the routes hereinafter described, subject, however, to the authority of this Commission to change or modify said routes at any time and subject to the following provisions:

- a. Applicant shall transport only passengers destined to or originating at the Los Angeles International, Ontario International and Orange County Airports.
- b. Applicant shall not pick up or discharge passengers except at El Toro Marine Air Station, Newport Beach, Santa Ana, Orange, Anaheim Territory\*, Fullerton, Buena Park, and the Los Angeles International, Ontario International and Orange County Airports. Specific points shall be named in applicant's tariff.

SECTION 2. ROUTE DESCRIPTIONS.

Subject to the authority of this Commission to change or modify such at any time, Airport Coach Service shall conduct its passenger stage operations between the following points and over and along the following described routes:

Newport Beach, Orange County Airport, Santa Ana,  
Orange, Anaheim Territory\*, Buena Park

Commencing at the Newporter Inn, Jamboree Road and Pacific Coast Highway, Newport Beach; thence along Jamboree Road, Palisades Road, MacArthur Boulevard to Orange County Airport; thence along MacArthur Boulevard, Newport Avenue, Santa Ana Freeway and East First Street to the Saddleback Inn, 1660 East First Street, Santa Ana; thence along East First Street, Santa Ana Freeway, Main Street to Santa Ana-Orange, #32 Town & Country, Orange; thence along Main Street, Garden Grove Freeway, Santa Ana Freeway, to the Anaheim Territory\*, thence (1) over the most direct or appropriate route or routes to the San Diego Freeway, thence along San Diego Freeway and Century Boulevard to the Los Angeles International Airport, or (2) leaving the Anaheim Territory\* northwest on the Santa Ana Freeway and Manchester Avenue to 6333 Manchester Avenue, Buena Park; thence over and along the most direct or appropriate route or routes to the Los Angeles International Airport, subject, however, to local traffic regulations. Also, along the Santa Ana Freeway between the Garden Grove Freeway and Artesia Boulevard.

SECTION 2. ROUTE DESCRIPTIONS (Continued)

Newport Beach, Anaheim Territory\*,  
Fullerton, Buena Park

Commencing at the Newporter Inn, Jamboree Road and Pacific Coast Highway, Newport Beach, thence along Pacific Coast Highway, Newport Avenue, Harbor Boulevard to the Anaheim Territory\*\*; thence (1) over and along the most direct or appropriate route or routes to the San Diego Freeway, thence along the San Diego Freeway and Century Boulevard to the Los Angeles International Airport, or (2) leaving the Anaheim Territory\* by way of Anaheim Boulevard (formerly Los Angeles Street), thence north on Anaheim Boulevard, Harbor Boulevard, Commonwealth Avenue, Malden Avenue, Whiting Avenue, Harbor Boulevard to the California Hotel, 305 North Harbor Boulevard, Fullerton; thence along Harbor Boulevard, Commonwealth Avenue, Beach Boulevard, and Manchester Avenue to 6333 Manchester Avenue, Buena Park; thence over and along the most direct or appropriate route or routes to the Los Angeles International Airport, subject, however, to local traffic regulations.

El Toro Marine Air Station - Los Angeles International Airport

Commencing at El Toro Marine Air Station, El Toro, California, thence via the most direct or appropriate route or routes to the Los Angeles International Airport.

Also

Commencing at El Toro Marine Air Station, El Toro, California, thence via Trabuco Road, Santa Ana Freeway, East First Street to Saddleback Inn, 1660 East First Street, Santa Ana.

Shuttle Service

Supplementary shuttle service to connect with through service may be conducted between the Anaheim Territory\*, on the one hand, and El Toro Marine Air Station, Newport Beach, Santa Ana, Orange, Fullerton or Buena Park, on the other hand, over any authorized route or combination of routes.

ONTARIO INTERNATIONAL AIRPORT - ANAHEIM TERRITORY\*,  
CALIFORNIA

Beginning at the airline passenger terminal at Ontario International Airport, thence along Vineyard Avenue, Holt Avenue, Euclid Avenue, California State Highway 71 Riverside Freeway, Harbor Boulevard, to the Anaheim Territory\*, California.

ALTERNATE ROUTE: ONTARIO INTERNATIONAL AIRPORT -  
ANAHEIM TERRITORY\*, CALIFORNIA

Beginning at the airline passenger terminal at Ontario International Airport, thence along Vineyard Avenue, San Bernardino Freeway, California State Highway 39, Manchester Avenue, Santa Ana Freeway, to the Anaheim Territory\*, California.

DESCRIPTION OF ANAHEIM TERRITORY

The Anaheim Territory is that portion of the City of Anaheim, the City of Garden Grove, the City of Orange and Orange County that is bounded as follows:  
on the north by Lincoln Avenue, on the west by Brookhurst Street, on the south by Chapman Avenue and on the east by the Santa Ana River, all streets inclusive.
