SUPPLEMENTAL OPINION AND ORDER

By Decision No. 74532 dated August 13, 1968, in this proceeding, the Commission found that Distance Table 7 as set forth in Exhibit 1, Part 1 of 2 parts containing the Rules and Constructive Mileage Tables and Part 2 containing the separate Book of Maps, modified to the extent set forth in that decision, contain the reasonable constructive miles and governing rules to be used in connection with the Commission's minimum rate tariffs in place of Distance Table 6 and that the resulting changes provide just and reasonable minimum rates and rules. The Commission concluded that Distance Table 7 and its Book of Maps should be adopted to supersede Distance Tables Nos. 5 and 6 effective January 1, 1969, that all minimum rate tariffs now referring to either Distance Table No. 5 or 6 should be amended accordingly and that distribution of Distance Table 7 and amendments of the various tariffs involved should be made by subsequent orders.

Preparation of Distance Table 7 and its Book of Maps and the cancellation supplements to Distance Tables Nos. 5 and 6 have been completed. Distribution will be accomplished by the order herein. The necessary amendments to the minimum rate tariffs will be made by separate orders.

IT IS ORDERED that:

- 1. Distance Table No. 5 (Decision No. 66578, as amended) is further amended by incorporating therein, to become effective January 1, 1969, Cancellation Supplement No. 15 attached hereto and by this reference made a part hereof.
- 2. Distance Table 6 (Decision No. 72081, as amended) is further amended by incorporating therein, to become effective January 1, 1969, Cancellation Supplement 2 attached hereto and by this reference made a part hereof.
- 3. Distance Table 7 and its Book of Maps which accompany this order are, by this reference, made a part hereof.
- 4. The Secretary is hereby directed to cause a copy of this order to be served forthwith upon the respondents to this proceeding and upon all other parties of record.

This order shall become effective on the date hereof.
