## C P I N I O N

Reliable Transportation Company, a highway common carrier and petroleum irregular route carrier, engaged in intrastate and interstate operations, requests the following:

- 1. Termination of the suspension of its certificated authority granted by Decision No. 42623, dated March 15, 1949, in Application No. 29759, and Decision No. 44384, dated June 20, 1950, in Application No. 31242.
- 2. A change of name of the operator of said certificate from Reliable to applicant Calzona Transportation, Inc., an Arizona corporation, authorized to do business in California, pursuant to a lease arrangement.
- 3. A declaration that upon the approval by the Interstate Commerce Commission of the proposed acquisition of Reliable by Calzona that the operating rights referred to will be transferred to Calzona.

On June 25, 1968, this Commission suspended the operating authority herein considered at the request of Reliable so that said carrier could effect an orderly liquidation to meet the needed funds to settle the estate of a shareholder. On July 10, 1968, applicants entered into a written agreement whereby Calzona would acquire the

A. 50555 hjh operating authority of Reliable. On August 12, 1963, the Interstate Commerce Commission, pursuant to Sections 5 and 210(a) and (b) cf the Interstate Commerce Act, authorized Calzona to lease the operating authority of Reliable, including that herein considered, pending formal determination of the transfer. After consideration, the Commission finds that public convenience and necessity require the granting of the application. A public hearing is not necessary. CRDER IT IS ORDERED that: 1. Upon the effective date hereof the operating authority granted by Decisions Nos. 42623 and 44384, is hereby reinstated. 2. Within thirty days after the effective date hereof and on not less than ten days' notice to the Commission and to the public, applicant shall amend the tariffs presently on file with this Commission in the name of Reliable Transportation Company to show that said operations are being provided by Calzona Transportation, Inc., pursuant to the lease agreement approved by the Interstate Commerce Commission. 3. Upon approval of the Interstate Commerce Commission of the proposed transfer of the operating authority covered by ordering paragraph 1 hereof and upon the filing with this Commission of a -2A. 50555 hjh certified copy of such order, this Commission will issue its order

transferring said authority to Calzona Transportation, Inc.

The effective date of this order shall be twenty days after the date hereof.
