O P I N I O N

By its verified application Suburban Water Systems requests authorization of the transfer of a portion of its City of Glendora system to the City.

The portion of the system, which has been condemned, lies in and adjacent to the City of Glendora. The entire Glendora system serves approximately 2,000 customers and is completely segregated from all other water systems of the applicant-seller.

The portion of the system in the City of Glendora which is to be sold includes approximately 182 domestic water services.

The consideration is \$98,280 pursuant to an order of condemnation by the Superior Court of the State of California in and for the County of Los Angeles. This amount of money has been paid by the City to the seller. Applicant-seller has obligations under main extensions in the portion of the system condemned in said City. These obligations will be paid in full with the November 1, 1969 payment (Exhibit 1).

The settlement price of \$98,280 has been deposited with the Trustee under the terms and conditions contained in an Original Trust Indenture dated October 1, 1953, as supplemented from time to time. Said Original Trust Indenture and its supplements are on file with this Commission.

Upon consideration of the allegations of the application, we find that:

1. The transfer should be authorized.
2. All balances due on main extension contracts on the portions of the system acquired by the City of Glendora will be paid by November 1, 1969.
3. All customers' deposits made by customers transferred to the City of Glendora have been refunded to said customers.
4. A public hearing is not necessary.

The Commission concludes that the transfer should be authorized.

O R D E R

IT IS ORDERED that:

1. On and after the expiration date hereof Suburban Water Systems may transfer and City of Glendora may acquire the portion of the water system referred to in the application.
2. After the effective date hereof and on not less than ten days' notice to the Commission and to the public, Suburban Water Systems shall amend its tariff presently on file with the Commission to reflect the transfer herein indicated.
3. Concurrent with the tariff filings of Ordering Paragraph 1, and upon assumption of service by the City of

Glendora, Suburban Water Systems may discontinue serving the area and customers herein considered and be relieved of its obligations to serve said area and customers.

3. The refunds due under main extension contracts for the portion of the service area sold to the City of Glendora shall be paid in full by Suburban Water Systems on or before November 1, 1969. Within ten days after payment of all such refunds Suburban Water Systems shall so advise this Commission in writing.

The effective date of this order shall be twenty days after the date hereof.
