## ORDER REVOKING PETROLEUM IRREGULAR ROUTE CERTIFICATE

By Decision No. 62867, dated November 29, 1961, in Application No. 43843, E. E. Fairbanks and D. E. Fairbanks, a copartnership, acquired a certificate of public convenience and necessity to operate as a petroleum irregular route carrier.

The certificate was suspended effective October 10, 1968, for failure to maintain on file evidence of adequate liability insurance coverage.

E. E. and D. E. Fairbanks have notified the Commission in writing that they have discontinued operations as a petroleum irregular route carrier and do not intend to offer this service in the future.

Review of the carrier's 1967 annual financial report indicates no petroleum irregular route carrier operations were conducted for the year 1967.

Investigation by the Commission staff discloses that the carrier has disposed of all of its petroleum bulk tank vehicles and is performing transportation pursuant to its radial highway common carrier and highway contract carrier permits.

In the circumstances, it appears, and the Commission finds, that public convenience and necessity no longer require the carrier's service. A public hearing is not necessary. The Commission concludes that the certificate should be revoked and the tariffs applicable to the service thereunder should be canceled.

## IT IS ORDERED that:

 The certificate of public convenience and necessity acquired by E. E. Fairbanks and D. E. Fairbanks by Decision No. 62867, dated November 29, 1961, in Application No. 43843, is hereby revoked.

2. Western Motor Tariff Bureau, Inc., Agent, is hereby authorized and directed to cancel the participation of E. E. Fairbanks and D. E. Fairbanks from its tariffs on file with the Commission, such cancellation to be made within ninety days after the effective date of this order on not less than ten days' notice to the Commission and to the public.

The Secretary is directed to cause service of a certified copy of this order to be made upon E. E. Fairbanks and D. E. Fairbanks or mail a certified copy thereof to them at their last known address as shown in the Commission's records and to mail a copy of this order to Western Motor Tariff
