OPINION AND ORDER

Alma Mae Marsh, doing business as Felix Marsh Transfer, holds radial highway common carrier, highway contract carrier and household goods carrier permits. Decision No. 73672, dated January 30, 1968, in Application No. 49110, authorized her to assess rates and charges in cents per hour or per piece as named in Minimum Rate Tariff No. 4-B (used household goods) in lieu of the minimum rates otherwise applicable as set forth in Minimum Rate Tariff No. 2 in connection with the transportation of property for The Pacific Telephone and Telegraph Company, Western Electric Company and Radio Corporation of America.<sup>1</sup> The current authority is scheduled to expire with February 1, 1969. By this application, she seeks renewal of this authority.

Applicant alleges that since the granting of the current authority she has performed transportation services for the shippers,

all as alleged in the prior application and as set forth in Decision No. 73672, supra, and that all of the conditions under which these services were performed have remained the same.

Revenue and expense data furnished by applicant indicate that the transportation involved has been profitable and reasonably may be expected to be profitable during the ensuing year.

A copy of the application was served by mail on California Trucking Association on December 30, 1968. The application was listed on the Commission's Daily Calendar of January 3, 1969. No objection to the granting of the application has been received.

In the circumstances, it appears, and the Commission finds, that the proposed rates are reasonable for the transportation in question. A public hearing is not necessary. The Commission concludes that the application should be granted.

Because the transportation conditions involved herein may change at any time, the authority will be made to expire at the end of one year. In view of the impending expiration date of the current authority, the order which follows will be made effective February 1, 1969.

IT IS ORDERED that:

1. Alma Mae Marsh, doing business as Felix Marsh Transfer, is hereby authorized to quote and assess rates and charges in the units of measurement set forth in Items Nos. 330 and 340 of Minimum Rate Tariff No. 4-B and no lower than the rates and charges named in those items, in lieu of the minimum rates in cents per 100 pounds otherwise specified in Minimum Rate Tariff No. 2, in connection with the transportation of property for The Pacific Telephone and

Telegraph Company, Western Electric Company and Radio Corporation of America.

2. The authority herein granted shall, on and after February 1, 1969, supersede the authority granted by Decision No. 73672 and shall expire with February 1, 1970.

This order shall become effective February 1, 1969.
