OPINION AND ORDER

Distance Table 7 contains the basis for determining constructive mileages in connection with various minimum rate tariffs issued by the Commission. By this petition, California Trucking Association seeks the establishment of constructive mileages between points in the Vandenberg Air Force Base and points adjacent thereto.

Petitioner states that Vandenberg Air Force Base has developed into a significant source of traffic for motor carriers. It asserts that more precise distances for the determination of rates are required in this area.

The Freight Economics Branch of the Commission's Transportation Division staff has determined appropriate mileages between points in the area involved as set forth in a report prepared by it. The staff report is received in evidence in this proceeding as Ex Parte Exhibit No. 1.

In the circumstances, it appears, and the Commission finds, that:

1. The constructive mileages set forth in the supplement attached hereto are reasonable and justified.

2. The proposed revisions of Distance Table 7, when applied in conjunction with minimum rate tariffs subject thereto, will result in just, reasonable and nondiscriminatory minimum rates for transportation governed by said tariffs.

3. To the extent that the provisions of Distance Table 7 heretofore have been found to constitute reasonable rules and distances for common carriers as defined in the Public Utilities Code, the provisions of said distance table as hereinafter modified are, and will be, reasonable provisions for said carriers.

4. To this same extent, existing rules and distances which are maintained by said common carriers for transportation within California are and, for the future, will be unreasonable, insufficient and not justified by the actual competitive rates of competing carriers or by the cost of other means of transportation insofar as they are lower in volume or effect than those set forth in Distance Table 7, as hereinafter modified.

5. A public hearing is not necessary.

The Commission concludes that the petition should be granted.

IT IS ORDERED that:

1. Distance Table 7 (Decision No. 74532, as amended) is further amended by incorporating therein, to become effective March 29, 1969, the supplement and revised pages attached hereto and listed in Appendix A also attached hereto, which supplement and tariff pages are by this reference made a part hereof.

2. Tariff publications required to be made by common carriers as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than the tenth day after the effective date of this order on not less than ten days' notice to the Commission and to the public and such tariff publications shall be made effective not later than March 29, 1969; and tariff publications which are authorized but not required to be made by common carriers as a result of the order herein may be made effective not earlier than the tenth day after the effective date of this order, and may be made effective on not less than

ten days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the tariff pages incorporated in this order.

3. Common carriers are authorized to adopt the supplement and revised tariff pages to Distance Table 7, listed in Appendix A, attached hereto, as a basis for computing distances for use of applying distance rates in their common carrier tariffs for the transportation of:

- (a) commodities for which minimum rates have not been established, or
- (b) commodities which are subject to higher rates than, or more restrictive provisions than, the minimum rates or provisions otherwise applicable.

4. Common carriers, in establishing and maintaining rates based on the mileages and other provisions authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the rates published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

5. In all other respects Decision No. 74532, as amended, shall remain in full force and effect.

This order shall become effective twenty-four days after the date hereof.

INDEX OF POINTS - EXPLANATION OF SYMBOLS AND REFERENCES

This index lists all Red Points and Black Points shown on the Constructive Mileage Maps and certain other locations within Metropolitan Zones, incorporated cities or Extended Areas.

A. Explanation of certain symbols and references used in the columns captioned "Point" or "Community"

1. All cities, communities, and points are listed alphabetically.
2. All Metropolitan Zones and numbered junctions are listed numerically.
3. * Indicates a Red Point; absence of symbol indicates a Black Point.
4. + Indicates the Point, community or other named area is subject to the provisions contained in Notes 1 or 2 below.
5. * Indicates an incorporated city, not within a Metropolitan Zone.
(See Note 3)

B. Explanation of symbols and references used in the columns captioned "Reference"

1. References to Maps 2-U, 2-V, 2-W, 3-X and 3-Y and maps numbered 5 and higher are for information purpose only and are not necessary for computation of distances.
2. Map references indicate the map number and the coordinates within which the Point appears on the map. For example, the reference "Map 1, B-7," indicates that the Point is located on Map 1 within the box designated by coordinates B and 7.
3. MZ followed by a number (as "MZ 201") refers to the Metropolitan Zone of that number. Where reference is thus made to a single Metropolitan Zone, the Point, community or other named area lies wholly within such Metropolitan Zone, and the Constructive Mileage shall be that applicable from and to such Metropolitan Zone. (See Note 1)
4. MZ followed by more than one number (as "MZ 204, 205, 215") refers to the Metropolitan Zones of those numbers. Where reference is thus made to more than one Metropolitan Zone, the community or other named area lies partly within each of such Metropolitan Zones. The Constructive Mileage shall be that applicable from and to whichever of such Metropolitan Zones encompasses the Point in question. (See Note 1)
5. "SEE" followed by the name of an incorporated city (as "SEE * LIVERMORE," or "SEE * AMADOR CITY") indicates that the Point or community lies wholly within the exterior limits of that incorporated city, or within the Extended Area of that incorporated city. The Constructive Mileage shall be that applicable from and to the Mileage Basing Point for such incorporated city in accordance with Rule 2. (See Note 2)
6. "SEE" followed by a numbered junction, or the name of an unincorporated community or other named area (as "SEE 2548," or "SEE * CROCKETT") indicates that the Point or community lies within the Extended Area of such numbered junction, unincorporated community, or other named area. The Constructive Mileage shall be that applicable from and to the Mileage Basing Point for such numbered junction, unincorporated community, or other named area in accordance with Rule 2. (See Note 2)
