
## OPINION AND ORDER

By this application, Western Motor Tariff Bureau, Inc., seeks authority on behalf of Cargo Carriers, Inc., M and M Transfer Company, Paxton Trucking Company and Ringsby-Pacific, Ltd., to publish increased hourly rates and accessorial charges for the transportation of property of unusual size, weight or handling characteristics, which require the use of, and are transported on, low-bed equipment.<sup>1</sup>

Applicant proposes: (1) to increase the straight time and overtime rates by 70 and 75 cents per hour, respectively, for the above transportation in equipment with weight capacities of 44,000 pounds and less; (2) to increase the hourly charges for various accessorial services by amounts ranging from 5 cents to \$1.00 per hour;<sup>2</sup> (3) to extend the area within which the charges

for overtime and for furnishing a teamster foreman would apply:<sup>3</sup> and (4) to cancel the charges for services by a "machinery helper". The increased rates and charges proposed herein are set forth in detail in Appendix "A" attached to the application.

Applicant states that the handling of shipments on lowbed equipment and the special accessorial services require the use of extremely specialized equipment as well as highly trained personnel. Applicant alleges that since March 1, 1968, when the rates and charges involved in this proposal were last adjusted, further increases in labor and other costs have occurred in connection with these specialized transportation services.

Applicant declares that it is not seeking increases in all of the rates and charges for the services involved. Applicant avers that studies made by the carriers in question indicate that the sought increases are actually needed and that such increases generally apply to services performed in connection with the carriers' lower weight-capacity equipment. Applicant states that cancellation of charges for services performed by a "machinery helper" is proposed inasmuch as this type of helper is no longer a factor in the day-to-day workings of the carriers.

Applicant asserts that increases resulting from the proposal herein would not increase the California intrastate gross revenue derived by each of the carriers involved by as much as one percent.

The application was listed on the Commission's Daily Calendar of December 23, 1968. No objection to the granting of the application has been received.

In the circumstances, it appears, and the Commission finds, that increases resulting from the publication of rates and charges as specifically proposed in the application are justified. A public hearing is not necessary. The Commission concludes that the application should be granted.

IT IS ORDERED that:

1. Western Motor Tariff Burcau, Inc., Agent, is hereby authorized to publish, on behalf of Cargo Carriers, Inc., M and M Transfer Company, Paxton Trucking Company and Ringsby-Pacific, Ltd., increased rates and charges in its Local, Joint and Proportional Freight and Express Tariff No. 111, Cal.P.U.C. No. 15, as specifically proposed in the application.

2. Tariff publications authorized to be made as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and to the public.

3. The authority herein granted shall expire unless exercised within ninety days after the effective date of this order.
