SUPPLEMENTAL ORDER

Decision No. 74059, dated April 30, 1968, in Application No. 50144, authorized the transfer of cement carrier certificate of public convenience and necessity from H. Norman Johnson, Jr. and E. Moe McCook, a copartnership doing business as J & M Trucking Co. to J-M Cement Carriers, Inc. The transfer was consummated on May 24, 1968.

The above authority is restricted as to the use of subhaulers transporting property of J-M Cement Carriers, Inc., H. Norman Johnson, Jr. and/or E. Moe McCook or Fourth Street Rock Crusher.

It has been brought to the Commission's attention by letter from the carrier that H. Norman Johnson, Jr., E. Moe McCook and Fourth Street Rock Crusher are no longer affiliated with and have no interest in J-M Cement Carriers, Inc. The Commission was further advised that E. W. French & Sons, Inc., a corporation, on June 26, 1968 acquired J-M Cement Carriers, Inc. by purchase of 100% of its stock, which acquisition has been confirmed by the staff.

After consideration the Commission finds the restriction should be amended to reflect the aforementioned changes in affiliations of the carrier. This being a matter not adverse to the public interest, a public hearing is not necessary.

O R D E R

IT IS ORDERED that Appendix A of Decision No. 74059 in Application No. 50144 is hereby amended by incorporating therein First Revised Page 1 attached hereto and by this reference made a part hereof in place of Original Page 1.

The effective date of this order shall be twenty days after the date hereof.

J-M Cement Carriers, Inc., by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to conduct operations as a cement carrier as defined by Section 214.1 of the Public Utilities Code, from any and all points of origin to all points and places within the following counties:

Contra Costa, Fresno, Imperial, Kern, Los Angeles, Marin, Merced, Napa, Orange, Riverside, San Bernardino, San Diego, San Francisco, San Joaquin, Santa Barbara, Sonoma and Ventura.

RESTRICTION:

Whenever J-M Cement Carriers, Inc., engages other carriers for the transportation of property of J-M Cement Carriers, Inc., or E. W. French & Sons, Inc., or customers or suppliers of said corporations, J-M Cement Carriers, Inc., shall not pay such other carriers rates and charges less than the rates and charges published in J-M Cement Carriers, Inc.'s tariffs on file with the Commission for the transportation actually performed by such other carriers.
