No. 1 (Express), and 19 (Freight), of C. R. Nickerson, Agent, to publish increased charges covering the transportation of Wooden Poles when carrier makes special trip for immediate delivery of LCL shipment (Rule 426, Exhibit "A"), and to provide Loading and Unloading Charges for certain commodities as proposed in new Rule 356.1, (Exhibit "B" hereof), as hereinafter provided.

## CPINION AND ORDER

By this application, C. R. Nickerson, Agent, on behalf of Speedy Transport, Incorporated (Speedy), seeks authority: (1) to establish a minimum charge of \$15.00 per hour, subject to a minimum of two hours, for service when the carrier is called upon to make a special trip for immediate delivery of a less-than-truckload shipment of wooden poles; (2) to cancel, in connection with stringing services, unloading charges of 5 cents per 100 pounds when the distance between origin and destination is 100 constructive miles

or less and 6 cents per 100 pounds when such distance is more than 100 constructive miles; and (3) to establish a charge of 5 cents per 100 pounds, based upon the weight on which transportation charges are assessed, for the service of loading or unloading pipe, culvert, fencing, posts or poles.

According to applicant, there have been many instances when shippers, primarily Pacific Gas and Electric Company and The Pacific Telephone & Telegraph Co. have called upon Speedy to transport less-than-truckload shipments of poles on an emergency basis to replace poles which have been blown down by heavy storms, toppled by slides on mountain slopes, burned by forest fires or damaged by motor vehicles. Applicant alleges that, in most instances, the time consumed in these emergency trips from Speedy's terminal and return thereto amounts to three hours or more and that the current less-than-truckload rates and minimum charges do not cover the carrier's out-of-pocket costs.

Applicant states that the proposed cancellation of the current provisions for assessing charges for unloading in connection with stringing services and the establishment of a charge of 5 cents per 100 pounds for loading or unloading are necessary inasmuch as Speedy is called upon to load onto or unload from its equipment pipe, culvert, fencing, posts or poles at various yards and stockpiles. Applicant alleges that the cost for loading or unloading

Applicant proposes to publish the sought tariff revisions in his Pacific Coast Tariff Bureau Local and Joint Freight and Express Tariff No. 16, Cal.P.U.C. Nos. 1 (Express) and 19 (Freight). The proposed rates and charges are set forth in detail in Exhibits "A" and "B" attached to the application.

A public hearing is not necessary. The Commission concludes that the application should be granted.

## IT IS ORDERED that:

- 1. C. R. Nickerson is authorized to publish in, and concurrently cancel from, Pacific Coast Tariff Bureau Local and Joint Freight and Express Tariff No. 16, Cal.P.U.C. Nos. 1 (Express) and 19 (Freight), for and on behalf of Speedy Transport, Incorporated, rates and charges as specifically proposed in the application.
- Tariff publications authorized to be made as a result of the order herein shall be filed not earlier than the effective date of this order and may be made effective not earlier than thirty days after the effective date of this order on not less than thirty days' notice to the Commission and to the public.

3. The authority herein granted shall expire unless exercised within ninety days after the effective date of this order.

This order shall become effective twenty days after the date hereof.
