JOHANSEN'S SUPERIOR TRUCK CO.

for an Order Excluding Certain Specified Commodities from its Highway Common Carrier Certificate. Application No. 51061 (Filed May 7, 1969)

OPINION

Johansen's Superior Truck Co., presently providing service as a highway common carrier for the transportation of general commodities between points in Southern California, requests that the following commodities be excluded from its certificated authority:

Beverages, flavored, phosphated or carbonated, nonalcoholic; flavoring syrup; beverage preparations; bottler's flavoring compounds.

It is alleged that applicant is in the process of acquiring all of the outstanding stock of Export Forwarders, Inc., doing business as Triangle Express (Triangle), a permitted carrier; it is the long term intention to ultimately merge the operations of applicant and Triangle, but pending complete acquisition, it is the intention to operate the two corporations as separate entities; Triangle presently transports substantial traffic for Coca-Cola Company in Southern California and pursuant to Decision No. 75256 is authorized to deviate from the minimum rates on the transportation of beverages and related commodities; and because of a possible alter ego situation the authority herein sought is necessary.

After consideration the Commission finds that the requested authority would not be adverse to the public interest. A public hearing is not necessary.

ORDER

IT IS ORDERED that:

- 1. Appendix A of Decision No. 62285 in Application No. 43060 is hereby amended by incorporating First Revised Page 2 attached hereto and by reference made a part hereof in place of Original Page 2.
- 2. Within sixty days after the effective date hereof and on not less than two days notice to the Commission and to the public, applicant shall amend its tariffs presently on file with this Commission to reflect the authority herein granted.
