SUPPLEMENTAL OPINION AND ORDER

By Decision No. 74082 dated May 7, 1968, as amended by Decision No. 74541 dated August 13, 1968, the Commission amended the certificates of various highway common carriers of general commodities by excluding therefrom the transportation of trailer coaches and campers for failure on the part of such carriers to file the required tariffs for the involved transportation.

The certificate of Presto Delivery Service, Inc., was inadvertently amended by Decisions Nos. 74082 and 74541 when the required tariff filings had been made by it. Also Appendix A of Decision No. 74082, as amended, contains an incorrect authority reference to the operative rights of Don D'Onofrio.

In the circumstances, it appears and the Commission finds, that the aforementioned certificate should be amended to reinstate therein authority to transport trailer coaches and campers and that the necessary corrections in said Appendix A should be made by the order herein. A public hearing is not

necessary. The Commission concludes that Decision No. 74082, as amended, should be further amended accordingly.

IT IS ORDERED that:

1. Appendix A of Decision No. 74082, as amended, is further amended by incorporating therein Second Revised Pages 3 and 8 attached hereto, in revision of First Revised Pages 3 and 8.

2. In all other respects, Decision No. 74082, as amended, shall remain in full force and effect.

The Secretary is directed to cause service of a certified copy of this order to be made upon Western Motor Tariff Bureau, Inc., and Leland C. Smith, Agent.

This order shall become effective on the date hereof.
