INTERIM ORDER

M.G.R.S., Inc., presently authorized to operate as a common carrier of passengers by vessel between the Port of Los Angeles and Avalon on Santa Catalina Island, requests an increase in fares. Applicant proposes to increase fares as follows:

Applicant proposes to adjust the 10-ride commute ticket from \$15.00 to \$30.00.

Applicant did not operate during the 1968 season due to the failure of management and the unions representing the operating personnel of the S.S. Catalina to arrive at labor contracts. Agreements have been reached and contracts have been signed for the 1969 season for a period of 93 operating days, from June 14, 1969, to September 14, 1969. Because of increased labor costs and wharfage costs at Los Angeles and Avalon applicant estimates that operating costs will increase in excess of \$110,000 over 1967.

For a test period of 12 months commencing June 15, 1969, through June 14, 1970 (93 days' operation of steamer) applicant's summary of estimated earnings under present and proposed fares is as follows:

Pending final determination of the instant application applicant requests an interim increase of 25 cents one way effective June 14, 1969. It is estimated that the interim increase would amount to \$76,470 in additional revenues for the 1969 season.

After consideration the Commission finds that the proposed interim increases are just and reasonable.
