SUPPLEMENTAL OPINION AND ORDER

By Decision No. <u>75841</u>, issued today in Case No. 5432, et al, the Commission found that the expiration dates governing the provisions in Minimum Rate Tariffs Nos. 1-B, 2, 5, 9-B and 19, which exempt the transportation of certain liquids, compressed gases and related commodities from the application of the minimum rates in such tariffs, should be extended from June 29, 1969 to December 31, 1970. The decision also provided that Minimum Rate Tariff No. 1-B should be amended by separate order to avoid duplication of tariff distribution.

IT IS ORDERED that:

1. Minimum Rate Tariff No. 1-B (Appendix B of Decision No. 65834, as amended) is further amended by incorporating therein, to become effective June 29, 1969, Eighth Revised Page 14 attached hereto and by this reference made a part hereof.

2. Tariff publications required to be made by common carriers as a result of the order herein may be made effective not earlier than the second day after the effective date of this order on not less than two days' notice to the Commission and to the public and such tariff

publications shall be made effective not later than June 29, 1969, and tariff publications which are authorized but not required to be made by common carriers as a result of the order herein may be made effective not earlier than the second day after the effective date of this order and may be made effective on not less than two days' notice to the Commission and to the public if filed not later than sixty days after the effective date of the minimum rate tariff page incorporated in this order.

3. Common carriers, in establishing and maintaining the amendments authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding authorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the amendments published under this authority shall make reference to the prior orders authorizing long- and short-haul departures and to this order.

4. In all other respects, Decision No. 65834, as amended, shall remain in full force and effect.

This order shall become effective on the date hereof.
