<u>ORDER</u>

In a decision issued today in the captioned proceedings, the Commission found that the minimum rates should be established on Shell Marl in Minimum Rate Tariffs Nos. 2 and 14-A, and that Minimum Rate Tariff No. 14-A should be amended by separate order.

IT IS ORDERED that:

1. Minimum Rate Tariff No. 14-A (Appendix A to Decision No. 67397, as amended) is hereby further amended by incorporating therein, to become effective March 15, 1970, Fourth Revised Page 5-A and Fourth Revised Page 31-B, attached hereto and made a part hereof.

2. Tariff publications required to be made by common carriers as a result of the order herein shall be filed not earlier than February 24, 1970, and shall be made effective March 15, 1970 on not less than ten days' notice to the Commission and to the public.

3. Common carriers subject to the Public Utilities Act, to the extent that they are subject also to Decision No. 67397, as amended, are hereby directed to establish in their tariffs the increases necessary to conform with the further adjustments ordered herein.

4. Common carriers maintaining rates on a level other than the minimum rates for transportation for which rates are prescribed in Minimum Rate Tariff 14A are authorized to increase such rates only to the level of Minimum Rate Tariff 14A rates authorized herein.

5. Common carriers, in establishing and maintaining the rates authorized hereinabove, are hereby authorized to depart from the provisions of Section 460 of the Public Utilities Code to the extent necessary to adjust long- and short-haul departures now maintained under outstanding authorizations; such outstanding suthorizations are hereby modified only to the extent necessary to comply with this order; and schedules containing the rates published under this authority shall make reference to the prior orders authorizing longand short-haul departures and to this order.

6. In all other respects Decision No. 67397, as amended, shall remain in full force and effect.

The effective date of this order shall be twenty-four days after the date hereof.
