SUPPLEMENTAL OPINION AND ORDER

By Decision No. 60528, dated August 9, 1960, in Applica-
tion No. 42429, Cerutti & Thompson Transportation Co. acquired a
certificate of public convenience and necessity to operate as a
petroleum irregular route carrier granted by Decision No. 44247,
dated May 26, 1950, in Application No. 31151.

Cerutti & Thompson Transportation Co. filed with this
Commission a certified copy of certificate of amendment of
articles of incorporation, which have been filed with the Secretary
of State, changing the corporate name to Cerutti & Sons Transporta-
tion Co.

Accordingly, the certificate will be amended to show the
new corporate name. The carrier will also be ordered to amend its
tariffs pursuant to General Order No. 80-A. A public hearing is
not necessary.

IT IS ORDERED that:

1. Decision No. 60528, dated August 9, 1960, in Applica-
tion No. 42429, is amended by substituting "Cerutti & Sons Trans-

portation Co" in place and stead of Cerutti & Thompson Transportation Co.

2. Within sixty days after the effective date hereof, and on not less than five days' notice to the Commission and to the public, Cerutti & Sons Transportation Co. shall amend its tariffs on file with this Commission as required by Rule 6.4 of General Order No. 80-A.

3. Cerutti & Sons Transportation Co. shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If Cerutti & Sons Transportation Co. elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

4. Except as amended herein, Decision No. 60528 shall remain in full force and effect.

This order shall become effective on the date hereof.
