ORDER AMENDING DECISION AND DENYING REHEARING

Petitions for rehearing of Decision No. 76236 having been filed by American Courier Corporation, M.P.A. Courier Corporation and Pacific Motor Trucking Company, the Commission having considered ✓ each and every allegation thereof, and being of the opinion that no good cause for rehearing has been made to appear, but that certain amendments should be made therein, and Application No. 51458 having been filed in accordance with said decision by American Courier Corporation, a corporation, for a certificate of public convenience and necessity to operate as an express corporation of special commodities between points in the State of California, and the Commission finding that no hearing thereon is required,

IT IS ORDERED that Decision No. 76236 is amended as follows:

1. Paragraphs 2 and 3 of Appendix A^c of Decision No. 76236

are deleted, and the following language substituted therefor:

"MPA Courier Corporation shall establish door-to-door rates for service between all points of collection and distribution."

2. Paragraphs 3 and 4 of Appendix B of said decision are deleted, and the following language substituted therefor.

"American Courier Corporation shall establish door-to-door rates for service between all points of collection and distribution."

3. Paragraph 4 of the Order in said decision shall include the following exemption in addition to those stated therein:

"Minimum Rate Tariff No. 19"

4. The following sentence is added to Paragraph 1 of the said order:

"A certificate of public convenience and necessity is hereby granted to M.P.A. Courier Corporation authorizing it to operate as an express corporation as defined in Section 219 of the Public Utilities Code via the lines of air common carriers as set forth in Appendix A-1 attached hereto and made a part hereof, contingent upon the payment of a filing fee of \$500.00 pursuant to Section 1010(b) of the Public Utilities Code."

5. The following sentence is added to Paragraph 2 of the said order:

"A certificate of public convenience and necessity is hereby granted to American Courier Corporation authorizing it to operate as an express corporation as defined in Section 219 of the Public Utilities Code via the lines of air common carriers as set forth in Appendix B-1 attached hereto and made a part hereof."

IT IS FURTHER ORDERED that rehearing of Decision No. 76236, as amended herein, is denied.

American Courier Corporation, by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to operate as a freight forwarder as defined in Section 220 of the Public Utilities Code via the lines of air common carriers between all points and places within the State of California subject to the following limitations:

1. The authority is limited to the following commodities: business records, audit media, tabulation cards, data processing materials, checks, drafts, securities, transit items, radioactive pharmaceuticals and film.

2. Shipments shall not exceed 50 pounds from one consignor to one consignee except work in process in which the limitation is 100 pounds per shipment.

3. American Courier Corporation shall establish door-to-door rates for service between all points of collection and distribution.

4. In case of an emergency, such as an airport being closed because of weather conditions which would curtail the operations of air common carriers, highway common carriers or passenger stage corporations may be used to perform transportation between airports.

2. Shipments shall not exceed 50 pounds from one consignor to one consignee except work in process in which the limitation is 100 pounds per shipment.

3. American Courier Corporation shall establish door-todoor rates for service between all points of collection and distribution.

4. In case of an emergency, such as an airport being closed because of weather conditions which would curtail the operations of air common carriers, highway common carriers or passenger stage corporations may be used to perform transportation between airports.
