## $\underline{O P I N I O N}$

This is an application by Southern California Gas Company seeking authority to exercise the rights and privileges under a franchise granted it by the City of Ontario.

Applicant presently furnishes gas service in the City of Ontario. It presently conducts operations under a franchise granted it by the County of San Bernardino. The franchise became effective in June of 1941. The Commission granted Southern California Gas Company a certificate of public convenience and necessity to exercise the franchise in Decision No. 34728.

The verified application avers that the City Council of the City of Ontario enacted Ordinance No. 1711, which grants Southern California Gas Company a franchise to indefinitely conduct its gas business in the city. The franchise would supersede the previously mentioned county franchise with respect to the area lying within the city limits. Southern California Gas Company has included in the application a stipulation that it will not claim before this Commission, or any court or other public body, any value for the franchise in excess of its original cost which is stated to be \$172.10.

As indicated that franchise here under consideration is contained in Ordinance No. 1711 of the City Council of the City of Ontario, which is attached to the application as Exhibit A. Examination of the Ordinance indicates that the franchise granted therein is of the standard type between gas utilities and cities. It provides for a payment of two percent of applicant's annual gross receipts arising out of the use, operation or possession of the franchise, provided however, that such payment shall in no event be less than one percent of the gross annual receipts of applicant derived from the sale of gas within the city limits.

The Commission is of the opinion that the application should be granted. No other points require discussion.

The Commission makes the following findings and conclusions in this matter.

## Findings of Fact

The Commission finds that:

1. A public hearing is not necessary in this matter.


2. Public convenience and necessity require the exercise by Southern California Gas Company of the rights and privileges granted in the franchise conferred by Ordinance No. 1711 of the City Council of the City of Ontario.

## Conclusions of Law

The Commission concludes that:

1. The application should be granted.

2. The certificates of public convenience and necessity issued herein are subject to the following provisions of law:



- 1. The Commission shall have no power to authorize the capitalization of the franchise involved herein or these certificates of public convenience and necessity, or the right to own, operate or enjoy such franchise or certificates of public convenience and necessity in excess of the amount (exclusive of any tax or annual charge) actually paid to the State or to a political subdivision thereof as the consideration for the issuance of such franchise, certificates of public convenience and necessity or right.
- 2. The franchise involved herein shall never be given any value before any court or other public authority in any proceeding of any character in excess of the cost to the grantee of the necessary publication and any other sum paid by it to the municipality therefor at the time of the acquisition thereof.

## ORDER

IT IS ORDERED that a certificate of public convenience and necessity is granted to Southern California Gas Company to exercise the rights and privileges conferred by the franchise, issued pursuant to Ordinance No. 1711 of the City Council of the City of Ontario.

The effective date of this order shall be twenty days after the date hereof.
