O P I N I O N

Marie Delliplaine, doing business as Delliplaine Truck Company, requests an order of the Commission authorizing her to sell and transfer a highway common carrier certificate of public convenience and necessity and related assets to Delliplaine Truck Company, Inc., and authorizing the latter to assume liabilities and to issue 540 shares of its no par value common capital stock on the basis of \$100 per share.

Said certificate was created by Decision No. 64335, dated October 2, 1962, as modified by Decision No. 64353, dated October 3, 1962, in Application No. 43673. It authorizes the transportation of certain specific commodities in portions of Kern and Los Angeles Counties. For the year 1968, the carrier reports total operating revenues and net income of \$213,354 and \$11,344, respectively.

Delliplaine Truck Company, Inc. is a California corporation incorporated on or about October 24, 1968. In exchange for 540 shares of its capital stock, the corporation proposes to acquire assets, subject to liabilities, of the sole proprietorship known as Delliplaine Truck Company. The assets and liabilities as of January 1, 1969, are summarized from Exhibit C, attached to the application, as follows:

After consideration the Commission finds that: (1) the proposed transactions would not be adverse to the public interest; (2) the money, property or labor to be procured or paid for by the issue of the stock herein authorized is reasonably required for the purpose specified herein; and (3) such purpose is not, in whole or in part, reasonably chargeable to operating expenses or to income. On the basis of these findings we conclude that the application should be granted. A public hearing is not necessary.

The action taken herein shall not be construed as a finding of the value of the properties to be transferred. So far as the rights are concerned the authorization herein granted is for the transfer of the highway common carrier certificate of public convenience and necessity only. Any transfer of permitted operative rights must be the subject of a separate application or applications.

The order which follows will provide for, in the event the transfer is consummated, the revocation of the certificate presently held by Marie Delliplaine and the issuance of a certificate in appendix form to Delliplaine Truck Company, Inc.

Delliplaine Truck Company, Inc. is hereby placed on notice that operative rights, as such, do not constitute a class of property which may be capitalized or used as an element of value in rate fixing for any amount of money in excess of that originally paid to the State as the consideration for the grant of such rights.

Aside from their purely permissive aspect, such rights extend to the holder a full or partial monopoly of a class of business over a particular route. This monopoly feature may be modified or canceled at any time by the State, which is not in any respect limited as to the number of rights which may be given.

O R D E R

IT IS ORDERED that:

1. Marie Delliplaine, on or after the effective date hereof and on or before June 30, 1970, may sell and transfer, and Delliplaine Truck Company, Inc. may purchase and acquire, the highway common carrier certificate of public convenience and necessity and related assets referred to in the application. The transfer may be consummated as of December 31, 1968, for accounting purposes.
2. Delliplaine Truck Company, Inc., on or after the effective date hereof and on or before June 30, 1970, in acquiring said certificate and assets, may assume outstanding liabilities and issue not exceeding 540 shares of its no par value common capital stock on the basis of \$100 per share.
3. Delliplaine Truck Company, Inc. shall file with the Commission a report, or reports, as required by General Order No. 24-B, which order, insofar as applicable, is hereby made a part of this order.

4. Within thirty days after the consummation of the transfer herein authorized, Delliplaine Truck Company, Inc. shall notify the Commission, in writing, of that fact and within said period shall file with the Commission a true copy of any bill of sale or other instrument of transfer which may be executed to effect said transfer.

5. Delliplaine Truck Company, Inc. shall amend or reissue the tariffs on file with the Commission, naming rates and rules governing the common carrier operations herein to show that it has adopted or established, as its own, said rates and rules. The tariff filings shall be made effective not earlier than five days after the effective date of this order on not less than five days' notice to the Commission and the public, and the effective date of the tariff filings shall be concurrent with the consummation of the transfer herein authorized. The tariff filings made pursuant to this order shall comply in all respects with the regulations governing the construction and filing of tariffs set forth in the Commission's General Order No. 80-A. Failure to comply with and observe the provisions of General Order No. 80-A may result in a cancellation of the operating authority granted by this decision.

6. In the event the transfer authorized in Paragraph No. 1 hereof is consummated, a certificate of public convenience and necessity is granted to Delliplaine Truck Company, Inc. authorizing it to operate as a highway common carrier, as defined in Section 213 of the Public Utilities Code, between the points and over the routes particularly set forth in appendix A attached hereto and made a part hereof.

7. The certificate of public convenience and necessity granted in Paragraph No. 6 of this order shall supersede the certificate of public convenience and necessity granted by Decision No. 64335 as modified, which certificate is revoked effective concurrently with the effective date of the tariff filings required by Paragraph No. 5 hereof.

8. Within thirty days after the transfer herein authorized is consummated, Delliplaine Truck Company, Inc. shall file a written acceptance of the certificate herein granted. Delliplaine Truck Company, Inc. is placed on notice that, if it accepts the certificate of public convenience and necessity herein granted, it will be required, among other things, to comply with and observe the safety rules of the California Highway Patrol and the insurance requirements of the Commission's General Order No. 100-E.

9. Delliplaine Truck Company, Inc. shall maintain its accounting records on a calendar year basis in conformance with the applicable Uniform System of Accounts or Chart of Accounts as prescribed or adopted by this Commission and shall file with the Commission, on or before March 31 of each year, an annual report of its operations in such form, content, and number of copies as the Commission, from time to time, shall prescribe.

10. Delliplaine Truck Company, Inc. shall comply with the requirements of the Commission's General Order No. 84-Series for the transportation of collect on delivery shipments. If Delliplaine Truck Company, Inc. elects not to transport collect on delivery shipments, it shall make the appropriate tariff filings as required by the General Order.

11. This order shall become effective when Delliplaine Truck Company, Inc. has paid the fee prescribed by Section 1904.1 of the Public Utilities Code, which fee is \$108.

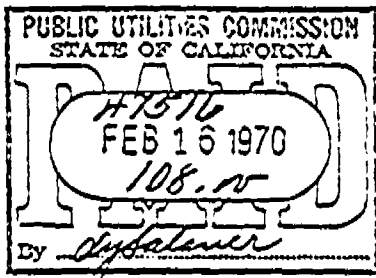

Delliplaine Truck Company, Inc., by the certificate of public convenience and necessity granted in the decision noted in the margin, is authorized to transport the commodities hereinafter listed between Los Angeles Territory, as described in Appendix B attached hereto, and Bakersfield and Oildale serving all intermediate points on and within four miles laterally of U.S. Highway 99, including points within a four-mile radius of Bakersfield.

Lateral and radial miles referred to in this appendix are statute miles of 5,280 feet each, measured in a straight line without regard to terrain features.

LOS ANGELES TERRITORY includes that area embraced by the following boundary: Beginning at the intersection of Sunset Boulevard and U. S. Highway No. 101, Alternate; thence northeasterly on Sunset Boulevard to State Highway No. 7; northerly along State Highway No. 7 to State Highway No. 118; northeasterly along State Highway No. 118 through and including the City of San Fernando; continuing northeasterly and southeasterly along State Highway No. 118 to and including the City of Pasadena; easterly along Foothill Boulevard from the intersection of Foothill Boulevard and Michillinda Avenue to Valencia Way; northerly on Valencia Way to Hillcrest Boulevard; easterly and northeasterly along Hillcrest Boulevard to Grand Avenue; easterly and southerly along Grand Avenue to Greystone Avenue; easterly on Greystone Avenue to Oak Park Lane; easterly on Oak Park Lane and the prolongation thereof to the west side of the Sawpit Wash; southerly along the Sawpit Wash to the north side of the Pacific Electric Railway right of way; easterly along the north side of the Pacific Electric Railway right of way to Buena Vista Street; south and southerly on Buena Vista Street to its intersection with Meridian Street; due south along an imaginary line to the west bank of the San Gabriel River; southerly along the west bank of the San Gabriel River to Beverly Boulevard; southeasterly on Beverly Boulevard to Painter Avenue in the City of Whittier; southerly on Painter Avenue to Telegraph Road; westerly on Telegraph Road to the west bank of the San Gabriel River; southerly along the west bank of the San Gabriel River to Imperial Highway; westerly on Imperial Highway to State Highway No. 19; southerly along State Highway No. 19 to its intersection with U. S. Highway No. 101, Alternate, at Ximeno Street; southerly along Ximeno Street and its prolongation to the Pacific Ocean; westerly and northerly along the shore line of the Pacific Ocean to a point directly south of the intersection of Sunset Boulevard and U.
