## ORDER REVOKING OPERATIVE RIGHT

S. A. Gilliard and Betty D. Gilliard possess a certificate of public convenience and necessity to operate as a petroleum irregular route carrier between points in Santa Barbara and Ventura Counties. This operative right was suspended on a voluntary basis from March 6, 1968, to December 31, 1969.

Oather C. Vance, Executor of the Estate of Sam A. Gilliard, and Betty D. Gilliard have by letter requested that the Commission revoke the certificate stating that the estate has sold the carrier's equipment and that other carriers are adequately performing the same service in the area covered by the certificate.

In the circumstances, it appears, and the Commission finds, that revocation of the certificate of public convenience and necessity as requested would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the certificate should be revoked and that the tariffs applicable to the services thereunder should be canceled.

IT IS ORDERED that:

 The certificate of public convenience and necessity to operate as a petroleum irregular route carrier acquired by
A. Gilliard and Betty D. Gilliard, by Decision No. 69235 dated
June 15, 1965, in Application No. 47541, is hereby revoked.

2. Vacuum Tank Truck Tariff No. 3, Cal.P.U.C. No. 3 (Series of John C. Moody), is hereby canceled.

3. C. R. Nickerson, Agent, is hereby authorized and directed to cancel the participation of Hollow Rod of California from the tariffs issued by Pacific Coast Tariff Bureau, such cancellations to be made within ninety days after the effective date of this order on not less than ton days' notice to the Commission and to the public.

4. The Secretary is directed to cause service of a certified copy of this order to be made upon Oather C. Vance, Executor of the Estate of Sam A. Gilliard, and Betty D. Gilliard or mail a certified copy thereof to them at their last known address as shown in the Commission's records and to mail a copy of this order to Barnes, Benton, Orr, Duval & Buckingham, 39 North California Street, Ventura, CA 93001, and C. R. Nickerson, Agent.

This order shall become effective twenty days after the date hereof.
