SUPPLEMENTAL OPINION AND ORDER

Decision No. 76956 in these proceedings authorized adoption of certain changes in Supplement 33 to National Motor Freight Classification A-10, hereinafter referred to as the Governing Classification.

It has come to the Commission's attention that a postponement in the effective date from April 23, 1970 to June 10, 1970 has been found necessary in connection with the provisions of Item 595 of the Governing Classification.

In the circumstances, it appears, and the Commission finds, that the necessary amendment to Ordering Paragraph 1 of

Decision 76956 should be made by the order herein. A public hearing is not necessary. The Commission concludes that Decision No. 76956, supra, should be amended accordingly.

IT IS ORDERED that:

1. Ordering Paragraph 1 of Decision No. 76956, dated March 17, 1970, in these proceedings is hereby amended to read as follows:

1. National Motor Freight Traffic Association, Inc., Agent, on behalf of the involved common carriers participating in National Motor Freight Classification A-10, is authorized to establish and publish the classification ratings and rules set forth in Application No. 51717 to become effective not earlier than April 23, 1970, except that revision in Item 595 may not be made effective earlier than June 10, 1970, on not less than five days' notice to the Commission and to the public.


2. In all other respects, Decision No. 76956 shall remain in full force and effect.

This order shall become effective April 23, 1970.
