OPINION AND ORDER

Edward James Nowotny (applicant) an individual doing business as Ed Nowotny Trucking seeks a permit as a dump truck carrier (Article 4.3 of Chapter 1 of Division 2 of the Public Utilities Code).

A public hearing on the application was held before Examiner Rogers in Los Angeles on April 22, 1970. The application was protested by permitted dump truck carriers.

The applicant presented evidence that he has experience as a dump truck operator; that he has a suitable dump truck; that he has the necessary insurance; and that he has the necessary finances. Section 3613 of the Public Utilities Code provides among other things, that:

"---before a permit to operate as a dump truck carrier is issued the Commission shall require the applicant to establish by a preponderence of evidence:

A. ----

O the total

C. that the privilege sought;

1. ----

3. is necessary to serve the public ---."

The applicant failed to produce any evidence by any shipper 1/of need for his services. The hearing was continued to May 5, 1970 to permit applicant to prove the public need for his services.

On April 29, 1970 the applicant requested that the matter be submitted on the record.

^{1/} Actually applicant presented evidence that he had been operating as a dump truck carrier without a permit and that he was paying the employing carrier (John Barnwell Trucking) 10 percent of his gross revenues. This is unlawful and additionally such payments are in violation of Item 94 of MRT No. 7.

The matter having been submitted and the applicant having failed to produce any evidence that his service "Is necessary to serve the public ---",

IT IS ORDERED that the application is denied.

The effective date of this order shall be twenty days after the date hereof.
