ORDER OF REVOCATION

Alfred F. Antoni, an individual, doing business as Antoni Truck Lines, possesses a certificate of public convenience and necessity to operate as a petroleum irregular route carrier as defined in Section 214 of the Public Utilities Code, between all points and places in the State of California. No operations have taken place under this authority for the past two years.

E. H. Griffiths, attorney-in-fact for the carrier, has by letter requested that the Commission revoke the certificate granted by Decision No. 65106 dated February 14, 1961, in Application No. 42740.

In the circumstances, it appears, and the Commission finds that revocation of the certificate of public convenience and necessity as requested would not be adverse to the public interest. A public hearing is not necessary. The Commission concludes that the certificate should be revoked and that the tariffs applicable to the services thereunder should be canceled.

IT IS ORDERED that:

1. The certificate of public convenience and necessity to operate as a petroleum irregular route carrier acquired by

Alfred F. Antoni, an individual, doing business as Antoni Truck Lines, by Decision No. 65106 dated February 14, 1961, in Application No. 42740 is hereby revoked.

2. Alfred F. Antoni Local Freight Tariff No. 1-I (C. R. Nickerson, Agent) Cal.P.U.C. No. 45, is hereby canceled.

3. C. R. Nickerson, Agent, is hereby authorized and directed to cancel the participation of Alfred F. Antoni from the tariffs issued by the Pacific Coast Tariff Bureau, such cancellations to be made within ninety days after the effective date of this order on not less than ten days' notice to the Commission and to the public.

4. The Secretary is directed to cause service of a certified copy of this order to be made upon Alfred F. Antoni or mail a certified copy thereof to him at his last known address as shown in the Commission's records and to mail a copy of this order to E. H. Griffiths, Transportation Consultant, 411 Turk Street, San Francisco, CA 94102 and C. R. Nickerson, Agent, c/o Pacific Coast Tariff Bureau, 9 First Street, San Francisco, CA 94105.

This order shall become effective twenty days after the date hereof.
